
Sub.: Change of Scrutinizer due to sad demise of Shri Pradeep Pincha.

1. The instant matter with respect to first motion application for fixing dates of meetings of shareholders and creditors was heard by the Tribunal and order thereon was pronounced on 01.04.2021.

2. The said order inter-alia provided for the meetings of the equity shareholders, secured creditors and unsecured creditors of the Applicant / Transferee Company, i.e. Sangam (India) Limited, to be held on 22.05.2021 through VC & OVAM in accordance with the Companies Act, 2013, and applicable Rules & Guidelines. Sh. Pradeep Pincha was appointed as the Scrutinizer for the said meetings and honorarium of the Scrutinizer was fixed at Rs. 1,25,000/- in addition to re-imbursement of incidental and out of pocket expenses.
3. An application has been moved before the Tribunal for filling of casual vacancy of, and appointment of another person as, Scrutinizer, for the said meetings to be held on 22.05.2021, due to death of Sh. Pradeep Pincha. Further, directions are sought to be given to the agency engaged for convening meetings and e-voting, i.e. Central Depository Services (India) Limited (CDSL).
4. The Tribunal condoles the demise of Sh. Pradeep Pincha, the professional duly assigned the task of Scrutinizer as per order of 01.04.2021.
5. As the process of e-voting has already started and the Transferee Company is a listed company, the exigency of circumstances warrants that the process for meetings be continued and an alternate person be appointed as Scrutinizer.
6. In view of the aforesaid situation, the Tribunal hereby appoints Sh. Akshit Kumar Jangid, Practicing Company Secretary (COP 16300), Jaipur (Mobile

No.7737196496, e-mail id: akshitjangid@gmail.com) as the Scrutinizer for conduct of meetings of stakeholders of the Applicant / Transferee Company.

7. The aforesaid Scrutinizer shall take over the process from the current stage till convening and conclusion of the meetings, completion of scrutiny and filing of report with respect to the meetings. The Company Secretary and officers of the Applicant / Transferee Company, and the Chairperson and Alternate Chairperson appointed for the meetings shall assist to provide due continuity. The said Sh. Akshit Kumar Jangid has been asked to join the hearing / proceeding in this matter through Video Conference and confirms that he will be able to take over the process with immediate effect.
8. In the peculiar facts of the case, an amount of Rs. 1,00,000/- shall be paid to the wife of Sh. Pradeep Pincha for the work already done by Sh. Pradeep Pincha for holding of the said meetings. Sh. Akshit Kumar Jangid shall be paid honorarium of Rs. 90,000/- for services as Scrutinizer from hereon. Incidental and out of pocket expenses shall be reimbursed in addition.
9. The Company Secretary and officers of the Applicant / Transferee Company shall assist to carry on the process uninterruptedly and inform the relevant stakeholders about appointment of Sh. Akshit Kumar Jangid as Scrutinizer by email and at the time of the meetings. The Company and its officers shall support the entire process in every way to ensure the smooth convening,

completion and conclusion of the meetings already called. No prejudice is caused to the process or expression of choice by the concerned stakeholders.

10. The Applicant / Transferee Company shall inform CDSL through email and all other possible modes immediately about this order which shall be read in conjunction with, and supplementary to, the order dated 01.04.2021. The order dated 01.04.2021 shall stand modified to the extent of directions given herein and shall be deemed to be so construed ab-initio. CDSL shall take all necessary steps required in view of this order to facilitate the discharge of responsibility by the Scrutinizer appointed herein in the vacancy arisen.
11. Notices, documents, publications, communications, etc. whether addressed to any one or more persons / entities / authorities or otherwise already made in context of the order dated 01.04.2021 shall be deemed to be amended from the inception in consonance with this order and directions given herein.
12. The Applicant / Transferee Company shall publish notice of this order on its website at the earliest and also send copy of this order to the concerned Income Tax Department, RoC and Official Liquidator concerned, Regional Director - MCA (North Western Region), SEBI, National Stock Exchange of India Ltd., BSE Ltd. as well as other concerned sectoral regulators and authorities.

14. The substitute Scrutinizer appointed herein shall file relevant reports within a week of conclusion of the meetings, as stated in the order dated 01.04.2021.

Copy of this order shall be signed by the Assistant Registrar, or in his absence, Office Assistant at the Registry of the Tribunal at Jaipur and provided in three copies to counsel for the Company besides being emailed to the Chairperson and Alternate Chairperson earlier appointed, and the Substitute Scrutinizer appointed herein.
