**EXTERNAL AFFAIRS MINISTER** S Jaishankar took a dig at the Western countries for treating democracy as a "Western characteristic", accusing them of not practising abroad what they value at home.

Jaishankar made these remarks at a panel discussion titled "Live to Vote Another Day: Fortifying Democratic Resilience" at the Munich Security Conference. He also said that "if you do want democracy eventually to prevail, it's important the West also embraces successful models (of democracy) outside the West.""There was a time — I have to say this in all honesty when the West treated democracy as a Western characteristic and was busy encouraging nondemocratic forces in the Global South. It still does. Everything

you value at home, you don't practice abroad. So, I do think the rest of the Global South will view the successes, shortcomings and the responses of other countries," he said.

## Israel, **Palestine** exchange hostages

HAMAS RELEASED ISRAEL hostages Iair Horn, Sagui Dekel Chen and Sasha (Alexander) Troufanov in Gaza on Saturday and Israel freed 369 Palestinian prisoners and detainees in exchange, after mediators helped avert a ceasefire collapse. The three Israelis were led onto a stage with Palestinian Hamas militants armed with automatic rifles standing on each side of them at the site in Khan Younis, live footage showed, before they were taken into Israel by Israeli forces.

Shortly afterwards, the first bus carrying freed Palestinian prisoners and detainees departed Israel's Ofer jail in the Israeli-occupied West Bank. The bus arrived in Ramallah to a cheering crowd, some waving Palestinian flags."We didn't expect to be freed, but God set us free," said Musa Nawarwa, 70, from the West Bank town of Bethlehem, who was serving two life terms for killings of Israeli soldiers in the West Bank He is a former commander of the Al-Aqsa Martyrs Brigades militant group. Argentina-born Iair Horn, 46, was taken captive together with his younger brother Eitan. Horn appeared to have lost considerable weight in captivity. The swap allayed growing alarm that the ceasefire agreement could unravel before the end of the 42-day first stage of the truce pact in effect since January 19.


