- At the end of the e-voting period on Thursday, March 16, 2023 (5.00 p.m. IST), the voting portal of NSDL was blocked forthwith.
- The votes were unblocked in the presence of 2 (two) witnesses, neither of whom are in the
 employment of the Company, and e-voting summary statement was downloaded from the evoting website of NSDL (https://www.evoting.nsdl.com).
