Tamil Nadu extends Covid-19 lockdown by a week from May 24

Tamil : Tamil Nadu on Saturday extended the Covid-19 lockdown by a week from May 24 without any relaxations. Earlier, the lockdown had commenced on May 10 to help prevent the spread of coronavirus disease (Covid-19) and it was supposed to end on May 24. Citing the view of medical experts that the coronavirus spread is likely to peak soon in Tamil Nadu, chief minister MK Stalin had earlier said that everyone must follow the Covid-19 related guidelines. "There were views that a third wave of the virus was also probable and we have to be ready to tackle it also. The day when no one was infected with the virus would really be a day of joy and only then would he be happy," Stalin said. Stalin also said that the pace of the coronavirus spread has been slowed down and the number of fresh infections has been controlled.

Indians vaccinated with Covaxin may not be allowed to travel abroad just yet



New Delhi : People who have been fully vaccinated by both doses of Covaxin might not be allowed to travel internationally as the vaccine produced by Bharat Biotech has not been included in World Health Organization's (WHO) Emergency Use Listing (EUL) so far, according to a report. Several nations in Europe are reopening in a bid to boost their travel and

Microbiology and Bharat Biotech's Covaxin are not yet approved by the UN health body. The European Union (EU), United Kingdom and Canada also have not included Covaxin in their approved list of vaccines. The WHO has not made any announcement so far regarding the inclusion of Covaxin in its EUL. Covaxin, according to WHO's Guideline Document on "Status of Covid-19 Vaccines within WHO EUL/PQ evaluation process", will be reviewed during a meeting which will be held between the months of May and June 2021. The document also showed that the Hyderabad-based pharmaceutical company has submitted its expression of interest on April 19.

JP University employees to donate one day salary to fight against Covid

Chapra, (Hindusthan Samachar) : The employees of Jai Prakash university have decided to donate one day salary to fight against the dreaded Covid-19. 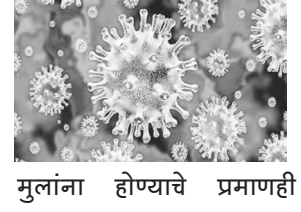
