# WHIRLPOOL OF INDIA DELIVERS STRONG INCOME GROWTH OF 31.5% FOR Q4 2020 – 2021

Full Year 2020-21 Revenue from Operations were at Rs. 5899.9 Cr and consolidated PAT Rs 351.8 Cr. Board of Directors of the Company at its meeting held today have recommended a Final Dividend of Rs. 5 per equity share of the face value of Rs. 10/- each (50%) for the financial year 2020-21.
