This is in furtherance to our intimation vide letter 18<sup>th</sup> October 2022 regarding setting up of Hybrid power project with a configuration of Wind Turbine Generator of 2.7 MW (1WTG of 2.7 MW) along with 0.675 MW AC/1.0125 MW DC solar power plant. The Windmill is installed at Revenue Survey No. 103 at Village Pipaliya, Talluka: Kalawad, District: Jamnagar and Solar Plant is installed at Revenue Survey No. 237 Paiki at Village Bediya, Talluka: Kalawad, District: Jamnagar.

We wish to inform you that the Company has received the project completion certificate from the supplier.
