है। संकल्प के अनुसार जिस प्रकार वर्ष 2024-25 के बजट में केंद्र सरकार ने 3 आपदा प्रभावित राज्यों सिक्किम, असम और उत्तराखंड के बाढ़ परियोजनाओं के लिए अनुदान संकल्प प्रस्ताव पर के रूप में सहायता देने की

हिमाचल को भी शतप्रतिशत सहायता राशि प्रदान की जाए। मुख्यमंत्री ने कहा कि केंद्रीय वित्त मंत्री ने सीधी सहायता देने के बजाय मल्टीलेटरल फंडिंग एजेंसी से बाह्य सहायता देने की बात कही है। यह सहायता 80:20 के अनुपात में मिलती घोषणा की है, उसी तर्ज पर है और प्रदेश को इसमें अपना

28 फीसदी हिस्सा देना पड़ता है। यही नहीं, मल्टीलेटरल फंडिंग एजेंसी से बाह्य सहायता परियोजना के अनुमोदन में भी काफी समय लगता है।

मुख्यमंत्री ने कहा कि एनडीआरएफ और एसडीआरएफ के तहत केंद्र से मिल रहा पैसा हिमाचल का अधिकार है और केंद्र यह पैसा देकर कोई खैरात नहीं बांट रहा है, क्योंकि यह राशि 15 वें वित्तायोग की सिफारिशों के अनुसार हर राज्य को दी जाती

उन्होंने कहा कि बीते वर्ष मानसून सीजन के दौरान 386 लोगों की मृत्यु हुई, जबिक कई लोग अभी भी लापता है।

शिमला। समुदाय विशेष के धार्मिक स्थल में अवैध निर्माण को तोड़ने की मांग को लेकर हिंदुवादी संगठनों ने संजौली बाजार में जोरदार प्रदर्शन किया। इस दौरान संजौली चौक से ढली टनल और यहां से वापस संजौली चौक पर लोगों ने एकत्रित होकर जमकर नारेबाजी की। प्रदर्शन को देखते हुए हुए मौके पर बड़ी संख्या में पुलिस बल तैनात रहा। प्रदर्शन के कारण दोपहर करीब डेढ़ घंटे वाहनों की आवाजाही प्रभावित रही। इससे लोगों को दिक्कतों का सामना करना पड़ा।

दोपहर में बड़ी संख्या में लोग संजौली चौक पर एकत्रित हुए। इसके बाद बाजार में विरोध रैली निकाली गई। इस दौरान पुलिस ने धार्मिक स्थल की ओर जाने वाले रास्तों पर पुलिस बल तैनात किया था। सबसे पहले सैकड़ों की संख्या में लोग नारेबाजी करते हुए ढली टनल की ओर रवाना हुए। इसके बाद दोबारा संजौली चौक पर पहुंचे। संजौली चौक

दी कि अगर दो दिनों में अवैध निर्माण नहीं तोड़ा तो वे हजारों की संख्या में एकत्रित होकर दोबारा प्रदर्शन करेंगे। इस दौरान लोगों ने जमकर नारेबाजी भी की।

लोगों में आक्रोश इस बात का था कि प्रशासन की आंखों के सामने सालों से अवैध निर्माण होता रहा लेकिन कोई कार्रवाई नहीं हुई। इसके अलावा लोगों ने प्रदेश सरकार से बाहर से आने वाले प्रवासी लोगों को पंजीकरण करने और सड़कों के किनारे अवैध रूप से रेहड़ी-फड़ी सजाने वालों के खिलाफ भी कड़ी कार्रवाई की मांग की।

लोगों का कहना है कि बाहर से आने वाले लोग शहर की कानून व्यवस्था को खराब कर रहे हैं। हिंदू जागरण मंच के पूर्व पदाधिकारी कमल गौतम ने लोगों को संबोधित करते हुए कहा कि सरकार को इस मामले में दो दिन के भीतर कार्रवाई करनी होगी। उन्होंने कहा कि शनिवार को नगर निगम आयुक्त की कोर्ट में इसकी सुनवाई

शिमला। हिमाचल प्रदेश की राजधानी शिमला के संजौली में समुदाय विशेष के धार्मिक स्थल में अवैध निर्माण मामले पर राजनीति भी तेज हो गई है। बुधवार को विधानसभा सदन में मामले पर विधायक हरीश जनारथा और मंत्री अनिरुद्ध सिंह आमने-सामने हो गए। वहीं मंत्री विक्रमादित्य सिंह ने कहा कि कानून अपने हिसाब से काम कर रहा है। हमें सभी की भावनाओं का सम्मान करना होगा। गुरुवार को लोक निर्माण मंत्री विक्रमादित्य सिंह ने सांसद असदुद्दीन ओवैसी की ओर से मामले पर सोशल मीडिया में दिए गए बयान पर पलटवार किया। विक्रमादित्य सिंह ने कहा कि हिमाचल प्रदेश में मोहब्बत है। यहां किसी के लिए नफरत नहीं है। समाज के हर वर्ग को आगे ले जाना हमारा दायित्व है। उनकी सुरक्षा करना हमारा दायित्व है और सरकार इसके लिए प्रतिबद्ध है। उन्होंने कहा कि प्रदेश की राजधानी शिमला के संजौली इलाके में अवैध निर्माण का जो मामला है,

यह मामला एमसी कोर्ट में लंबित है और काफी समय से इसकी सुनवाई चल रही है।

कोर्ट के फैसले अनुसार सरकार की ओर से इसमें कार्रवाई की जाएगी। उन्होंने कहा कि हिमाचल प्रदेश एक देवभूमि है। हिमाचल प्रदेश पहला राज्य है, जहां पर पूर्व कांग्रेस सरकार ने धर्मांतरण का कानून लागू किया। विक्रमादित्य सिंह ने कहा कि शिमला शहर के लोगों की चिंता है कि प्रदेश में बाहरी राज्यों से कुछ लोग आ रहे हैं। यह लोग यहां पर झूठी पहचान के साथ काम कर रहते हैं। इसे कानून व्यवस्था की दृष्टि से देखे जाने की जरूरत है। कोई भी व्यक्ति बाहरी राज्य से हिमाचल में आकर झूठी पहचान से काम करे, यह प्रदेश की आंतरिक सुरक्षा पर बहुत बड़ा प्रश्नचिन्ह है।
