I, CS Prabhat Maheshwari, Company Secretary in Practice (FCS: 2405, CP No: 1432), Partner of M/s. GMJ & Associates, was duly appointed by the Board of Directors of the Company for the purpose of scrutinizing the Remote e-voting process under the provisions of Section 108 of the Companies Act, 2013 read with Rules 20 and 21 of the Companies (Management and Administration) Rules, 2014 and MCA General Circular no. 20/2020 of 5th May, 2020 and Circular No. 02/2021 dated 13th January, 2021 and also SEBI Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated 12th May, 2020 and SEBI/HO/CFD/CMD2 /CIR/P/2021/11 dated 15th January, 2021, and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 including any amendment(s) thereof and evoting during the AGM in a fair and transparent manner in respect of the resolutions contained in the Notice of the 30th AGM of Equity Shareholders of the Company at their meeting held on Saturday, 25th September, 2021 at 11.00 A.M. through Video Conferencing (VC) / Other Audio Visual Means (OAVM).

The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and the Rules framed thereunder relating to voting through electronic means (remote e-voting) and e-voting during the AGM on the resolutions contained in the Notice of the 30th AGM of the members of the company. My responsibility as a Scrutinizer for the remote e-voting process and e-voting during the AGM is restricted to make a Scrutinizer's Report of the votes casted "in favour" or "against" the resolutions as stated below on the report generated from the remote e-voting system provided by National Securities Depository Limited (NSDL) the authorised agency engaged by the Company to provide remote e-voting facilities and e-voting system during the AGM.



We hereby submit our report as follows:

- The resolutions were transacted through the process of remote e-voting and through evoting system during the AGM. For the purpose of remote e-voting and e-voting system during the AGM, the Company has engaged NSDL for its services;
- Members attended the Meeting through VC/OAVM facility provided in accordance with the General Circular No. 20/2020 of 5th May, 2020 and other circulars issued by the Ministry of Corporate Affairs ("MCA") from time to time and were counted for the purpose of reckoning quorum under Section 103 of the Companies Act, 2013;
- 3. The cut-off date for the purpose of identifying Members who were entitled to vote on the resolutions placed for approval, was Monday, 20th September, 2021;
- 4. The period for remote e-voting commenced on Wednesday, 22<sup>nd</sup> September, 2021 at 9.00 A.M. and ends on Friday, 24<sup>th</sup> September, 2021 at 5.00 P.M. The remote e-voting module was disabled by NSDL for voting thereafter;
- 5. For the Members who did not cast their vote through remote e-voting facility, the Company has provided the facility of e-voting system during the AGM;
- 6. Further, the votes cast through remote e-voting and e-voting system during the AGM were unblocked by us today at 1:00 P.M. in the presence of two witnesses viz., Ms. Nirmal Gupta and Mr. Vishal Dhanak , neither of whom was in the employment of the Company and e-voting summary statement was downloaded from the e-voting website;
- 7. The votes were also scrutinized for the purpose of eliminating duplicate voting and the invalid votes, if any;
- 8. Our report on the results of e-voting is based on the data downloaded from the website of NSDL;
- 9. The data relating to e-voting process was reconciled with the records maintained by the Company/Registrar & Transfer Agents of the Company.
