- 6. Thereafter, on the instructions of the Chairman, the Company Secretary read out the qualified opinion mentioned in the Auditors Report and Secretarial Audit Report as well as the explanations/comments thereof, given by the Board of Directors in their Report.
- 7. The Chairman then addressed the shareholders and appraised the shareholders about the Company during the financial year ended on 31<sup>st</sup> March, 2021.

The Company Secretary informed the shareholders that pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company has provided an opportunity to all shareholders for casting their votes electronically in respect of the businesses transacted at the AGM. - (iii) To ratify the remuneration of the Cost Auditor for the financial year ending on 31st March, 2022.
