



The Company owns 3.5 floors in the building named “Suma Center” situated in Erandwane, Pune admeasuring around 26,320 square feet area. The proposed transaction is a material related party transaction pursuant to the Regulation 23 (1) of the SEBI (LODR) regulations, 2015, therefore prior approval of the members is being sought by way of passing a Ordinary Resolution.

The Audit Committee of the Board of Directors of the company recommended and the Board of Directors through a resolution passed in the meeting held on 26<sup>th</sup> December 2023 approved the proposed related party transaction subject to the approval of members of the company.

The Board of Directors is of the opinion that the proposed material related party transaction is in the interest of the Company.



Mr. Pranav Vijay Deshpande, (DIN 06467549) who is a common director in the Company and ACTIN Technologies India Pvt. Ltd. is interested in the proposed transaction. Except him, other Directors and Key Managerial Personnel of the Company and any of their relatives are not in any way, financially or otherwise concerned or interested in the resolution, except to the extent of shares in the company that may be held by them or their relatives or any entity in which they may be deemed to be concerned or interested.

Mrs. Jyotsna Kulkarni is one of the promoters of the Company and her son Mr. Nihal Kulkarni holds 90 % of the equity shares in ACTIN Technologies India. Pvt. Ltd.

Achyut and Neeta Holdings and Finance Private Limited is one of the entities amongst the promoters' group of the Company and holds 90 % of the Compulsorily Convertible Preference shares in ACTIN Technologies India. Pvt. Ltd.

The Board recommends the Ordinary Resolution set out at Item No. 1 of this of the Notice for approval by the members through Postal Ballot in accordance with Section 110, of the Companies Act, 2013, read with the Rules made thereunder, as amended from time to time.

#### **ITEM NO 2 OF THE NOTICE:**

Pursuant to the proviso of Regulation 45 (1) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the listed entity should change its name within a period of 6 months from the change in its activities if such change in activities is not reflected in its name. The listed entity is also required to satisfy the conditions laid down in sub-regulation (1) of Regulation 45.

The Company sought approval of the members for change in its name through postal ballot e-voting process during 03<sup>rd</sup> July 2023 to 01<sup>st</sup> August 2023. The resolution was approved by 99.99% of the members who casted their votes (the number of votes in favour of the resolution were 28,76,144 and number of votes against the resolution were 150).

However, the notice of postal ballot dated 28<sup>th</sup> June 2023 and the statement annexed to the notice was sent to the members of the Company without inadvertently procuring and attaching a certificate from practising chartered accountant certifying that the conditions for change in name as laid down in regulation 45 (1) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 are satisfied (herein after referred to as "Certificate from practising Chartered Accountant).

The Company after receiving approval from the members as on 01<sup>st</sup> August 2023 and fresh certificate of incorporation dated 31<sup>st</sup> October 2023 from the Registrar of Companies, had filed an application with BSE Ltd. for change in its name. The BSE Limited had informed the Company on 04<sup>th</sup> December 2023 regarding requirement of sharing proof of compliance regarding placing of certificate from practising Chartered Accountant before members of the Company at the time of approval for change in its name. The Company inadvertently had not procured and attached the certificate from practising Chartered Accountant pursuant to regulation 45 (3) of SEBI LODR. Hence the Company had submitted an undertaking dated 06<sup>th</sup>


