Sumeet Dhekale played yet another captain's knock to bail Chennai Singams out against Tigers of Kolkata in the Singams' penultimate league match of the Indian Street Premier League (ISPL) Season 2 at the Dadoji Konddev Stadium in Thane on Saturday.

Riding on Dhekale's quick-fire 31 (17b, 5x4), Singams recovered from a precarious 24 for four to finish its essay at 65 for seven in its stipulated 10 overs. The Tigers of Kolkata - who continued to remain at the bottom of the points table - then chased down the target in six overs, losing one wicket.

Dhekale, the stylish south-paw, though gave a lesson of how raw power and aerial hitting is not the be-all and end-all to succeed in cricket, especially tennis-ball cricket, as a batter. When the veteran batter - also a regular on Mumbai's maidan cricket circles - took guard in the fifth over, Singams were down

to 24 for four. Shivam Kumar was the Kolkata outfit's star performer, having picked three wickets in the second over of the match.
