Sl.	Details	Description
No. 1	Impact of the CoVID-19 pandemic on the business	As per the Directions of Government issued for Lock Down, the Company's business operations were suspended temporarily from 23.03.2020. Lock Down has impacted the Company's operations in the month of March, April, May and June. Accordingly it is expected that there will be challenges in next 2-3 months.
2	Ability to maintain operations including the factories/ units/ office spaces functioning and closed down	Due to sudden lock down, the productions were stopped temporarily and some office staffs were allowed to work from home.
3	Schedule, if any, for restarting the operations	Now, as per directions issued by Government, we have restarted our office and plants w.e.f. 8 th June, 2020.
4	Steps taken to ensure smooth functioning of operations;	The company has formulated SOP for maintaining healthy and hygienic working conditions for ensuring smooth functioning of business operations which includes social distancing, mandatory wearing of mask, hand sanitizer at the time of entering the factory premises and sanitization of entire factory on daily basis.
5	Estimation of the future impact of COVID-19 on its operations	Quarter-1 of financial year 2020-2021 is not be good due to lock down and partially restarting of business operations w.e.f. 08th June, 2020. Accordingly the profitability and cash flow of the company may be affected for the financial year 2020-2021.
6	Details of impact of CoVID-19 on listed entity's	Due to lock down, the profitability is likely to be affected. However, the Company can expect positive operating profit during the financial year.
7	Existing contracts / agreements where non-fulfilment of the obligations by any party will have significant impact on the listed entity's business	The Company will be soon able to fulfill the obligations in the existing orders/contracts.
8	Other relevant material updates about the listed entity's business	There are no other material updates to report.
