AIR INDIA EXPRESS TRAGEDY

KERALA CM ASKS ALL AGENCIES TO TAKE PART IN RESCUE OPS

PM Modi speaks to CM Vijayan, promises all assistance

AGENCIES
Thiruvananthapuram

Kerala Chief Minister Pinarayi Vijayan on Friday directed all state government agencies to engage in the ongoing rescue operations at the Kozhikode airport after an Air India Express aircraft skidded off the runway while landing there killing 14 passengers and injuring 123.

The Chief Minister directed officials to use all government facilities for the rescue operation, said the office of the Chief Minister (CMO).

According to the CMO, Vijayan has also deputed Minister for Local Self-Government AC Moideen to coordinate the rescue operations. As per reports, Moideen has already left for Karipur from Thrissur.

The Air India Express Dubai-Kozhikode IX-1344 flight, carrying 190 people on board from Dubai under the Vande Bharat Mission, over-shot during landing at Karipur Airport in Kozhikode on Friday evening.



The incident took place at 7.41 pm.

PM calls CM

PM Narendra Modi spoke to CM Vijayan over the phone about the plane accident at Kozhikode airport.

The Prime Minister promised all the assistance from the Centre.

The Chief Minister informed the Prime Minister that a team of officials including Kozhikode and Malappuram district collectors and Inspector General Ashok Yadav reached the airport and were involved in the rescue operation, a CMO release said.

Amit Shah asks NDRF to reach site

Home Minister Amit Shah on Friday said he was distressed to learn of accident of Air India Express aircraft in Kozhikode and had asked NDRF to reach the site at the earliest and assist in rescue

operations.

"Distressed to learn about the tragic accident of Air India Express aircraft in Kozhikode, Kerala. Have instructed NDRF to reach the site at the earliest and assist with the rescue operations," Shah said in a tweet.

The Directorate General of Civil Aviation (DGCA) has ordered a detailed probe into the incident.
