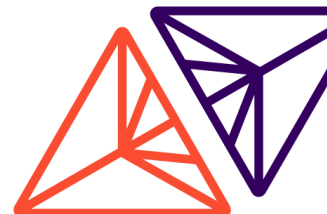

Re-appointment of Ms. Madhu Khatri (DIN: 00480442) as an Independent Director

To consider and if thought fit, to pass, with or without modification(s), the following resolution as a Special Resolution:

RESOLVED THAT pursuant to the provisions of Sections 149, 150, 152 and other applicable provisions, if any, of the Companies Act, 2013 (Act), the Companies (Appointment and Qualification of Directors) Rules, 2014, read with Schedule IV to the Act and Regulation 17 and other applicable regulations of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (Listing Regulations), as amended from time to time, Ms. Madhu Khatri (DIN: 00480442), who was appointed as an Independent Director at the Thirty Second Annual General Meeting of the Company for a term of up to three years and who is eligible for re-appointment and who meets the criteria for independence as provided in Section 149(6) of the Act along with the rules framed thereunder and Regulation 16(1)(b) of the Listing Regulations and who has submitted a declaration to that effect and in respect of whom the Company has received a notice in writing from a Shareholder under Section 160(1) of the Act proposing her candidature for the office of Director, be and is hereby re-appointed as an Independent Director of the Company, not liable to retire by rotation, to hold office for a second term of up to two years with effect from 29th July 2023.

NOTES

1. An Explanatory Statement pursuant to Section 102 of the Act, setting out material facts concerning the businesses stated in the Notice, is annexed hereto. The relevant details, pursuant to Regulations 26 and 36(3) of the Listing Regulations and Secretarial Standard on General Meetings issued by the Institute of Company Secretaries of India, in respect of Director seeking re-appointment is also forming part of said Statement.
2. Mr. Gopalakrishnaraj H H, Practicing Company Secretary (Membership No. FCS: 5654; CP: 4152) is appointed as the Scrutinizer for conducting the Postal Ballot through e-voting process in a fair and transparent manner. The Scrutinizer's decision on the validity of the Postal Ballot shall be final.
3. In compliance with the provisions of section 108 and 110 of the Act read with the Rules, the MCA Circulars and Regulation 44 of the Listing Regulations, the Company is providing the facility to all its members to exercise their right to vote by electronic means as an alternate mode of voting which will enable them to cast their votes electronically, for which necessary arrangements have been made by the Company with National Securities Depository Limited (NSDL) as the agency for providing e-voting facility. The instructions for e-voting provided as part of this Postal Ballot Notice which the members are requested to read carefully before casting their vote.
4. In compliance with the circulars, Notice of the Postal Ballot along with the Explanatory Statement is being sent only through electronic mode to those members whose names appear on the Register of Members / List of beneficial owners as on **11th August 2023 (Cut-off date)** and whose email address is registered with the Depositories / Company's Registrar & Transfer Agent (RTA).
5. PROCEDURE FOR E-VOTING

EXPLANATORY STATEMENT

As required under Section 102 of the Act and Regulation 36 of Listing Regulations, the following explanatory statement sets out material facts relating to business mentioned in the accompanying Notice and should be read as forming part of the Notice.

Ms. Madhu Khatri (DIN 00480442) born on 13th July 1963 was initially appointed as an Independent Director at the 32nd Annual General meeting held on 29th July 2020 for the 1st term of 3 years which ended on 28th July 2023.

Pursuant to Section 149, 150, 161 and other applicable provisions of the Act and the Listing Regulations, the Board on 28th July 2023, based on the recommendation of Nomination and Remuneration Committee, had appointed Ms. Madhu Khatri as an Additional Director in the capacity of Independent Director of the Company and recommended for her re-appointment for a 2nd term of up to 2 years with effect from 29th July 2023 to 28th July 2025 (both days inclusive) subject to the approval of the shareholders through special resolution.

She is a seasoned C-Suite executive with over 30 years of global experience working with multinational companies as a trusted advisor to corporate leaders on risk mitigation, compliance, reputation management, business strategy, mergers & acquisitions, and complex legal & policy issues. In the course of these 30 years, she has been the General Counsel of Microsoft India and the General Counsel of Wipro. Her experience includes being legal counsel at GE Health Care South Asia, advisory work at PWC & Arthur Andersen and extensive litigation experience in tax courts and the Supreme Court of India.

She graduated from Lady Shri Ram College with a B.A in Political Science (Hons), a Bachelor's in law (LL.B) from Delhi University and a Master's in Law (LL.M) from Columbia University.

She is a Member of Stakeholders Relationship Committee and Risk Management Committee of the Company.

She does not hold any equity shares of the Company and her office shall not be liable to retire by rotation.

Given her educational, professional background and experience, the Board had considered that her re-appointment for a 2nd Term of up to 2 years would be beneficial to the Company. In the opinion of the Board, she fulfils the conditions specified in the Act, the Rules made thereunder and Listing Regulations for her appointment as a Woman Independent Director of the Company and is independent of the management.

The Company has received a declaration from her to the effect that she meets the criteria of independence as provided in Section 149(6) of the Act and Rules framed thereunder and Regulation 16(1)(b) of the Listing Regulations.
