

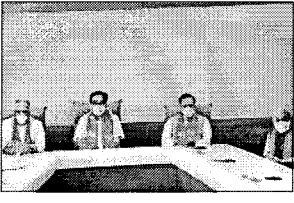

CHAIRMAN BY STATE BJP INCHARGE BJP begins planning for 2022 polls in core committee meet

GUJARAT BJP in presence of state party incharge Bhupendra Yadav held a meeting of the party's core committee on Friday where it started planning for the 2022 assembly elections keeping focus on the ongoing Covid-19 pandemic.

The meeting was held at the party's state headquarters Shree Karmalim even as Yadav also began his three-day tour of the state Friday.

Apna from Yadav, the meeting was attended by Chief Minister Vijay Rupani, state president C.R. Patil, Deputy Chief Minister Nirmal Patel and other members of the committee, including Union Minister Parthiv Mehta, Gujarat state ministers Bhupendra Patel Chaudhary and R.C. Faldu, state treasurer Surendra Patel, Shankar Chaudhary, vice-president Gordhan Zadharia, organizing secretary Bhikhabhai Dalwadi and general secretaries Pratipindi Vaghela, Bhargav Bharti, Vinod Chavhan and Rajiv Patel.

After the meeting, Patil addressed media and said that party incharge Yadav was apprised about various works done by the state government and party organisation during the Covid-19 pandemic and recent local election cycle that passed through the state after taking the coastal districts of Gir, Somnath, Bhavnagar and Anand.

"Primary discussions for the assembly elections (next year) were done in the meeting. Discussions were held on the state government's preparations and the role to be played by the party in it in the event of third

use of technology for (virtual) campaigning in the run up to the elections.

Yadav's visit has sparked speculation that it could be because of the alleged lack of coordination between the state government and the party organisation. However, replying to a question if the issue of coordination between the state government and the organisation was discussed at the meeting, Patil said, "The government and organisation are discharging their responsibilities with lots of honesty. The demand for coordination between them is understood there. So, there is no need for a special attempt for that because there is no lack of coordination."

Responding to a Congress allegation that Yadav's visit is owing to internal feud within the BJP, Patil said, "The BJP's performance and lack of coordination between the government and the organisation are the issues that we have to focus on. It is not because of any internal feud in any state. It is because of the coordination between the government and the organisation that we have to focus on. It became possible because of the coordination between the two."

Two Bihar natives arrested for killing man over monetary dispute

TWO YOUTHs, both natives of Bihar, were arrested on Friday for killing another man over monetary dispute in Vagra district of Bharuch district.

As per police, Ashwin Patel (39), a resident of Inayat village in Vagra taluka of Bharuch district, was on his way back home from work when he received a call from his friend Alam Mansuri, who asked him to meet. When Patel reached the deceased lodged a complaint with Vagra police station late

Thursday night. Bhauruch police on Friday arrested both Alam and Nasid.

Deputy Superintendent of Police of Bharuch A.C. Gohil said, "Alam had taken Rs 1.20 lakh from Patel on interest. Alam and Patel both work in the same factory. After primary investigations we have found that Alam had repaid the money with interest, but Patel had been demanding more money and also threatening him. Alam then told Nasid about it. On Alam's insistence, Nasid hatched the plan of killing Patel."

COUNTERFEIT CURRENCY CASE Accused allowed to stay back in UK for 1 more yr

THE SURAT district court on June 9 allowed a latest Kingdom resident who is accused in a counterfeit currency case to continue his stay in UK for 12 months from July 1, 2021 to June 30, 2022, in view of the Covid-19 situation in his native country India. The stay of the accused was granted on the condition that he should not intend to cheat the bank as such diverted the funds through other banking channel in his native country of India.
