MINUTES OF PROCEEDINGS FOR DECLARATION OF RESULTS OF THE POSTAL BALLOT BY MORARKA FINANCE LIMITED DECLARED ON MONDAY, DECEMBER 21, 2020, THROUGH VIDEO CONFERENCING:

The Company had on, Thursday, November 19, 2020, completed the dispatch of the Postal Ballot Notice dated Friday, November 13, 2020, through email to the Members of the Company as on Friday, November 13, 2020 ("the cut-off date") for seeking their approval by way of Ordinary Resolution for the Special Business contained in the said Notice.

The voting rights were reckoned in proportion to the paid-up value of the equity shares registered in the name of the Members as on Friday, November 13, 2020. Public Notice regarding the completion of dispatch of Postal Ballot Notice was published in The Business Standard and Mumbai Lakshdeep on November 20, 2020.

The Company had, in compliance with Regulation 44 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 and pursuant to Section 108 of the Companies Act, 2013, read with the Companies (Management and Administration) Rules, 2014, offered e-voting facility through Central Depository Services (India) Limited to all the Members of the Company to enable them to cast their votes electronically. The voting period (e- voting) commenced from Friday, November 20, 2020, at, (09:00 a.m.) and ends on Saturday, December 19, 2020, at (05:00 p.m.).

In Compliance with the MCA circulars, the communication of the assent or dissent of the Members was only taken place through the remote e-voting system and voting through physical ballot papers was not be provided.

The Board of Directors had appointed Mr. V K Mishra, Practicing Company Secretary, (COP No. 4279) as Scrutinizer for conducting the Postal Ballot (e-voting) process in a fair and transparent manner.

The Scrutinizer carried out the scrutiny of the votes cast electronically up to 05:00 p.m. on Saturday, December 19, 2020 and had submitted his Report dated Monday, December 21, 2020.

The Report submitted by the Scrutinizer was taken on record and the results given herein below were declared:
