- 2. The management of the Company is responsible to ensure the compliances with the requirements of provisions of the Companies Act, 2013 and Rules relating to voting through electronic me ans and Postal Ballot on the resolution set out in Postal Ballot Notice. My responsibility as a Scrutinizer for the voting process is restricted to ensure that the process of Postal Ballot with E-voting facility is conducted in a fair and transparent manner and make the Scrutinizer's Report of the votes cast "in favour" or "against" the resolution stated below, based on scrutiny of postal ballots (through E-voting) received from the members and on the reports generated from the e-voting system provided by the Central Depository Services (India) Limited ("CDSL"), the authorized agency to provide e-voting facilities, appointed by the Company.

The Company has, through its service provider, on 21st February, 2022, completed the dispatch/sending of notice of postal ballot together with explanatory statement setting out material facts to 137632 equity

shareholders whose E-mail IDs were available. Further, the Company has informed that it has given opportunity to all its members to register their E-mail ID with the Company/RTA/DP so as to participate in Postal Ballot through E-voting.

- 4. Further to the above, I submit my report as under:
  - a. I assumed the office as Scrutinizer w.e.f. 10<sup>th</sup> February, 2022.
  - b. The Company has appointed Central Depository System Limited to provide platform for E-voting. The e-voting facility was provided by CDSL on their portal i.e. <a href="https://www.evotingindia.com">https://www.evotingindia.com</a>.
  - c. It has also been intimated that the Company has published the public notice under Rule 22 (3) of the Companies (Management & Administration) Rules, 2014 by way of an advertisement published on 22<sup>nd</sup> February, 2022 in "Financial Express Ahmedabad edition" (English Language) and "Gandhinagar Samachar" (Gujarati Language).
  - d. The Postal ballot with E-voting remained open from Tuesday, 22<sup>nd</sup> February, 2022 (9.00 a.m.) and ended on Wednesday, 23<sup>rd</sup> March, 2022 (5.00 p.m.).
  - e. The Members of the Company as on "cut off" date i.e. 16<sup>th</sup> February, 2022 were entitled to vote on the resolution stated in the Notice of the Postal Ballot.
  - f. It has been confirmed by the Company/RTA that they have not issued any duplicate Postal Ballot Forms as there was no request required to be received from Shareholders in this regard.
  - g. During the period from 22<sup>nd</sup> February, 2022 to 23<sup>rd</sup> March, 2022 (i.e. total duration of atleast 30 days), 822 Equity shareholders in respect of 49,17,36,995 Equity shares participated for the exercise of their voting right through E-voting platform of CDSL.

There was no Postal Ballot Form required to be received physically in view of the MCA & SEBI circulars referred to in the Askal Ballot Notice.
