Lenders to Soon Drag Future Enterprises to Bankruptcy Court

Central Bank of India to seek technical, financial bids from RPs for Future unit some time next week

Mumbai: Lenders will soon initiate in solvency proceedings against Future Enterprises (FEL), the linchpin company of the Future Group, which manufactures, designs, procures and distributes fashion apparel for the group companies, said two people aware of the development.

The collapse of the ₹24,713-crore deal with Reliance Industries and defaults on a series of payments to lenders in the last week of March as per the terms of one-time restructuring (OTR) prompted lenders to pursue insolvency proceedings, the people said. The company has outstanding debt of ₹6,880 crore as of January 31, 2022. Lead bank Central Bank of India will seek technical and financial bids from resolution professionals for FEL some time next week.

 $FEL\,did\,not\,immediately\,respond\,to\,the$ ET's request for comments. As per stock exchange disclosures, FEL has defaulted on ₹2,911.5 crore payments to lenders between March 23 and March 31.

ET reported on Monday that lenders will prefer a holistic approach since their businesses are interrelated. The outstanding loans of the 20 group companies involved in the Reliance deal (which was called off last week) stood at ₹28,921 crore as of January 31.

Bank of India has already filed an application for insolvency proceedings against Future Retail (FRL) at Mumbai National Company Law Tribunal (NCLT) after defaulting on the ₹3,495-crore OTR payment in the last week of January. NCLT has approved group insolvency for Videocon Industries and the twin Srei companies. Lenders have selected Deloitte India-backed Vijaykumar Iyer as interim resolution professional for FRL.

Although NCLT has to admit a compay within 14 days of being referred under the Insolvency and Bankruptcy Code (IBC), the process typically takes at least three months. Reliance and Future formally called off the ₹24,713-crore deal announced in August 2020 after 69% of secured lenders voted against the plan while 86% of shareholders and 78% of unsecured creditors favoured the scheme. Secured lenders voted against the sale of assets to Reliance since they did not receive any comfort from the Future Group that the buyer would support the proposed distribution plan. Future had proposed transferring about 45% of the proceeds—amounting to ₹12,612 crore—to Reliance while it would repay the remaining loans over seven years. However, recovery under the bankruptcy route could be even lower at sub-10% because the value of the assets is much lower than Future's debt. The lease takeover of the 946 Future stores by Reliance Industries at the end of February was the turning point for the deal to go sour.

Antony Blinken says Moscow is trying to brutalise parts of Ukraine but failing in its war aims

Top American officials pledged on Monday to help ensure Ukraine wins its fight against Russia following face-to-face talks with President Volodymyr Zelenskyy in Kyiv, while Britain said Moscow has yet to achieve a significant breakthrough in its offensive in the eastern industrial heartland of the country.

In meetings with Zelenskyy, US Secretary of State Antony Blinken and US Defense Secretary Lloyd Austin said the United States had approved a \$165 million sale of ammunition for Ukraine's war effort, along with more than \$300 million in foreign military financing.

"The strategy that we've put in place - massive support for Ukraine, massive pressure against Russia, solidarity with more than 30 countries engaged in these efforts - is having real results," Blinken told reporters in Poland the day after meeting with Zelenskyy and other Ukrainian officials.

"When it comes to Russia's war aims, Russia is failing. Ukraine is succeeding. Russia has sought as its principal aim to totally subjugate Ukraine, to take away its sov-

An autopsy was underway by a team of veterinarians to determine the causes of the tigers' death, said Agus Arianto, who heads the conservation agency in Aceh, adding that several traps similar to ones used to capture wild boars on farms were found in the area around the dead tigers.

Snare traps are commonly used by farmers on Sumatra island to catch wild boars. However, poachers have

also used snare traps to kill endangered wildlife for economic purposes.
