Sub: Postal Ballot Notice dated 10th August 2019 - Interim Order of the Securities Appellate Tribunal, Mumbai ("SAT")

We refer to the captioned Postal Ballot Notice sent to the shareholders to seek their approval for the sale of Company's Undertakings at Delhi, Bengaluru, Chennai, Udaipur, Company's Hotel Operations Undertaking and Company's shareholding in Leela Palaces and Resorts Limited, a wholly owned subsidiary of the Company. As per the schedule, the e-voting commenced on 18th August, 2019 and will end on 16th September, 2019. The date of declaration of the results was scheduled to be 18th September 2019. The said Postal Ballot Notice was issued pursuant to the orders dated 23rd July 2019 and 30th July 2019 passed by SEBI (SEBI Order).

An appeal was filed by a shareholder against the aforesaid SEBI Order before the Hon'ble Securities Appellate Tribunal, Mumbai (SAT). Pursuant thereto, vide its order dated 13th September 2019, the Hon'ble SAT has reserved its judgment in the matter, and has directed the Company not to declare the result of the aforesaid Postal Ballot till SAT delivers its judgement in the matter.

We enclose herewith a copy of order issued by SAT in this regard.
