मंबई, दि. १३: ऐतिहासिक वारसा असलेल्या गांधी मैदानाला वाचविण्यासाठी कर्ल्यातील स्थानिक नागरिकांनी आवाज उठविण्यास सुरुवात केली आहे. या मैदानाचे हस्तांतर महानगरपालिकेकडे का केले जात नाही, असा सवालदेखील विचारण्यात येत आहे.

कुर्ला येथील गांधी मैदानाला ऐतिहासिक वारसा आहे. याच मैदानात स्वातंत्र्यपूर्व काळात महात्मा गांधी, नेताजी सभाषचंद बोस यांच्या सभा झाल्याचा इतिहास आहे. तसेच संयक्त चळवळीमध्ये या मैदानात सभाही झाल्या होत्या त्यामळे मैदानाला ऐतिहासिक महत्त्व आहे. मात्र ऐतिहासिक वारसा असलेल्या या मैदानाला अतिक्रमणाचा विळखा बसल्याचे चित्र आहे. दिवसेंदिवस या भागात वाढत जाणारे येथील अतिक्रमण आणि मैदान परिसरात चालणाऱ्या अनैतिक धंद्यांपासन या मैदानाला वाचवा. असा आकोश स्थानिक जनता करत आहे. या मैदानावर समाजकंटकांनी अतिक्रमण केले. त्याविरोधात येथील समाजमंडळांनी कायदेशीर लढा दिला. त्यामुळे या अवैधरीत्या वसल्या गेलेल्या झोपड्या हटवल्या गेल्या. मात्र. मैदानात एक पड़की वास्त आहे. तिथे समाजकंटकांद्वारे अवैध आणि अनैतिक धंदेही सर्रासपणे सुरू असतात. हे धंदे बंद करून या मैदानाचा पुनर्विकास होणे गरजेचे असल्याचे रुथानिकांचे म्हणणे आहे. यासाठी मैदानाचा ताबा महानगरपालिकेकडे देण्यासाठी स्थानिकांनी गेली दोन वर्षे सातत्याने संबंधितांकडे पाठपुरावा केला. 'गौरी-शंकर क्रीडा मंडळ' आणि ज्येष्ठ तसेच युवा मंडळ या जनआंदोलनाचे नेतृत्व करत आहेत. मात्र. कोरोनाकाळात या मैदानात मात्र पन्ता अवैधरीत्या झोपड्या बांधल्या गेल्या. या मैदान परिसरातच वाहनतळ बांधावे. यासाठी स्थानिक नगरसेवक उत्सक असल्याचे स्थानिकांचे म्हणणे आहे. मात्र, या ऐतिहासिक वारसा असलेल्या मैदानाला आम्ही वाचवणारच, असा निर्धार स्थानिकांनी केला आहे
