(એજન્સી) અમદાવાદ, બોપલ વિદ્યાર્થીની હત્યાકાંડ કેસમાં પોલીસે આજે રિકન્સ્ટ્રક્શન શરૂ કર્યુ હતુ, આજે બપોરના સમયે પોલીસના કાફલા સાથે આરોપી વિરેન્દ્રસિંહને લઇને પહોંચી હતી. આરોપીએ MICAના વિદ્યાર્થી પ્રિયાંશુ જૈનની ચપ્પૂના ઘા મારીને હત્યા કરી દીધી હતી.

૧૧ નવેમ્બરે મોડી રાત્રે બોપલમાં થયેલી MICA વિદ્યાર્થીની હત્યા કેસમાં આજે પોલીસ દારા સમગ્ર ઘટનાનું રિકન્સ્ટ્રક્શન કરવામાં આવ્યું હતુ, આ કેસને લઇને આજે બપોરે પોલીસ ટીમ કાફલા સાથે આરોપીને લઇને બોપલ પહોંચી હતી, આ દરમિયાન આરોપી વિરેન્દ્રસિંહ સતત રડતો હતો, અને પોતાની ગુનાની માફી માંગી રહ્યો હતો. વિદ્યાર્થીની હત્યા કરી તેના પર અફસોસ વ્યક્ત કરી રહ્યો હતો. રિકન્સ્ટ્રક્શન દરમિયાન આરોપી ખુલ્લા પગે અને ટીશર્ટમાં જોવા મળ્યો હતો, અને તેને દોરડા સાથે બાંધીને બોપલના રસ્તાં પર

ફેરવવામાં આવ્યો હતો. પોલીસે રિકન્સ્ટ્રક્શન કરીને સમગ્ર ઘટનાના પુરવાઓ વધુ મજબૂત રીતે એકત્રિત કર્યા હતા.

અમદાવાદમાં માઈકાના વિદ્યાર્થી પ્રિયાંશુ જૈનની હત્યા કેસમાં મોટો ખુલાસો થયો છે. હત્યાના આરોપી પોલીસકર્મી વિરેન્દ્રસિંહ પઢેરીયા સાથે અન્ય એક પોલીસ કર્મી હોવાનો ખુલાસો થયો છે. દિનેશ નામના પોલીસ કર્મીએ વિરેન્દ્રને ભગાડવામાં મદદ કરી હતી.

# ગુજરાત અને મહારાષ્ટ્રમાં કુલ ૨૩ સ્થળોએ દરોડા

અમદાવાદ, એન્ફોર્સમેન્ટ ડિરેક્ટોરેટ ની ટીમે મહારાષ્ટ્ર અને ગુજરાતમાં છેતરપિંડીના મામલામાં મોટી કાર્યવાહી કરી છે. મળતી માહિતી મુજબ તપાસ એજન્સી દ્વારા બંને રાજ્યોમાં કુલ ૨૩ સ્થળોએ દરોડા પાડવામાં આવ્યા છે. આ મામલો નકલી દસ્તાવેજો અને નકલી કેવાયસી દ્વારા મોટી સંખ્યામાં બેંક ખાતા ખોલવા સાથે સંબંધિત છે. મળતી માહિતી અનુસાર, ઈઢની ટીમે ગુજરાતમાં નાસિક, સુરત, અમદાવાદ, માલેગાંવ અને મુંબઈમાં ૧૩ સ્થળોએ દરોડા પાડ્યા છે. આ કેસનો આરોપી સિરાજ અહેમદ ચા અને ઠંડા પીણાની એજન્સી ધરાવે છે. આરોપીઓએ ગરીબ પૃષ્ઠભૂમિના લોકોને લલચાવી તેમના

દસ્તાવેજો લઈને બેંક ખાતા ખોલાવ્યા. ખાતું ખોલાવ્યા બાદ આરોપીઓએ એપીએમસી માર્કેટમાં નોકરી આપવાનું વચન આપ્યું હતું. આ ખોલવામાં આવ્યા હતા, જેમાં ૨૨૦૦ ટ્રાન્ઝેક્શન થયા હોવાનું જાણવા મળે છે. આ બેંક ખાતાઓ દ્વારા કુલ રૂ. ૧૧૨ કરોડ જમા થયા હતા, જ્યારે ડેબિટ બાજુએ ૩૧૫ વ્યવહારો થયા હતા. મુંબઈ ઈઢની ટીમે માલેગાંવ નાસિક મર્કેન્ટાઈલ બેંક પર એકથી વધુ બેંક ખાતા ખોલવા અને પછી બેનામીં ખાતાઓમાંથી રૂ. ૧૦૦ કરોડથી વધુની રકમ મેળવવાના અને પછી તેને બહુંવિધ બેનામી ખાતાઓમાં ટ્રાન્સફર કરવાના કેસમાં દરોડા પાડવા હતા જેણે તરત જ રકમ પાછી ખેંચી હતી. મની લોન્ડરિંગનો શંકાસ્પદ કેસ, કેટલાક રાજ્યોમાંથી ભંડોળ

ગેરકાયદેસર ઉપયોગ માટે ડાયવર્ટ કરવામાં આવ્યું હોવાની શંકા છે. આ ખાતા સિરાજ અહેમદ નામના વ્યક્તિ દ્વારા બનાવટી દસ્તાવેજોનો ઉપયોગ કરીને ખોલવામાં આવ્યા હતા અને હવે ED સિરાજ અહેમદ સાથે જોડાયેલા પરિસરમાં દરોડા પાડી રહી છે અને આરોપીએ જ્યાં ફંડ ટ્રાન્સફર કર્યું છે

ભારતીય જનતા પાર્ટીના નેતા કિરીટ સોમૈયાએ ૧૩ નવેમ્બરે સોશિયલ મીડિયા પોસ્ટમાં કહ્યું હતું કે, "હું સિરાજ અહેમદ, હાંરૂન મેમણના ૧૨૫ કરોડ રૂપિયાના માલેગાંવ વોટ જેહાદ કૌભાંડની તપાસ કરવા માટે આજે બપોરે ૨ વાગ્યે માલેગાંવ જઈ રહ્યો છું. હું બેંકમાં જઈશ. , પોલીસ સ્ટેશન અને કરિયાદીઓને મળો.''


