Hence this can not be the reason for increase in price and volume of the shares.

We have also noted that there was substantial change in the price and volume of shares of the company in the recent past. We confirm that Promoters/Directors and/or any Key Managerial person of the company are NOT involved in trading activities which could have resulted in rise in share price and volume of the shares of the company.
