Desai Finwealth Investments and Securities Private Limited ("DFISPL") and Onward Network Technologies Private Limited ("ONTPL") are Promoter shareholders of Onward Technologies Limited ("the Company"). Both, DFISPL and ONTPL hold in aggregate 88,97,566 equity shares of the Company constituting 39.89% of the share capital. Pursuant to the sanctioned Composite Scheme of Amalgamation and Arrangement ("Scheme"), Onward Software Technologies Private Limited ("OSTPL") is a Promoter of the Company in place of DFISPL and ONTPL.

Through a Composite Scheme of Amalgamation and Arrangement between DFISPL and ONTPL and OSTPL:

- i. DFISPL has been amalgamated with ONTPL; and
- ii. Securities Investment Business comprising of 88,97,566 equity shares of the Company have been demerged and transferred to OSTPL.
