In terms of Regulation 29(2) of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 ('SAST Regulations'), our percentage of shareholding in Texmaco Rail & Engineering Limited ('Texrail') has been changed pursuant to allotment of equity shares to other promoter groups under preferential basis by Texrail.

We have been holding 5,85,00,000 i.e. 26.02% equity shares in Texrail before 24<sup>th</sup> February, 2021 i.e. (*date of intimation of allotment*) and now our holding is 5,85,00,000 i.e. 23.37% equity shares in Texrail owing to further allotment of equity shares to other promoter groups under preferential basis. The overall change in our holding is -2.65%.
