However, immediately prior to the date of trade disclosed herein, VPMF, along with the KPAMF, sold an aggregate of 564,369 equity shares of the Company in multiple tranches. The current sale, being a sale by VPMF, along with KPAMF, of a total of 102,902 equity shares of the Company, equivalent to 0.316% of the shares of Company, has reduced the shareholding of VPMF, along with that of KPAMF, from 7.039% to 6.723% (this change is in excess of 2% from the last disclosure that was made for the trade on August 6, 2020) and has triggered this filing under Regulation 29(2) of the Takeover Code.
