प्राप्त जानकारी के मुताबिक मंडी-कुल्लू मार्ग पर शुक्रवार को कुल्लू से मंडी आ रही एक कार पर गिरी चट्टानों से एक युवक की मौत हो गई जबकि दो बुरी तरह से घायल हो गए।

# भूस्खलन से लाहडू-चुवाड़ी मार्ग पर आवाजाही ठप

आजादी के अमृत महोत्सव के दौरान शुक्रवार को तिरंगा यात्रा निकालते समय ऊना जिले के हरोली हलके के तहत दुलैहड़ गांव के राजकीय वरिष्ठ माध्यमिक विद्यालय के राजनीतिक शास्त्र विषय के प्रवक्ता जसवंत सिंह ढेसी की मौत हो गई। मृतक ऊना के गलुआ के रहने वाले थे। उनके साथ मौजूद अन्य शिक्षक उसे तुरंत दुलैहड़ अस्पताल ले गए, लेकिन यहां पर चिकित्सकों ने उन्हें मृत घोषित कर दिया। हादसे की सूचना मिलते ही टाहलीवाल पुलिस चौकी प्रभारी मनोज वालिया और परिजन मौके पर पहुंच गए। हरोली के डीएसपी

अनिल पटियाल का कहना है कि प्रवक्ता की मौत के सही कारणों का पता पोस्टमार्टम की रिपोर्ट के बाद चलेगा लेकिन शुरुआती जांच में हृदय गति रुकना मौत का कारण भी हो सकता है।

मंडी से लगभग 28 किलोमीटर दूर हणोगी के नजदीक जोगणी मंदिर के पास अचानक ऊपर से भारी चट्टान कार पर आ गिरी और कार चकनाचूर हो गई। कार में उस समय तीन लोग सवार थे। इनमें एक की मौत हो गई जबिक दो बुरी तरह से घायल हो गए। मृतक की पहचान सरकाघाट के गांव छातर भद्रवाड़ के तीस साल के रिव कुमार के रूप में हुई है जबकि घायलों में गांव जिहणा गैहरा का धर्मेंद्र व छा।तर भद्रवाड के राकेश कुमार शामिल है। दोनों घायल महेंद्रा फाइनेंस कुल्लु में काम करते हैं। घायलों को मंडी के जोनल अस्पताल में भर्ती करवाया गया है। थाना औट से आई पुलिस ने शव को अपने कब्जे में लेकर उसे पोस्टमार्टम के लिए अस्पताल भेजा।

रामपुर उपमंडल की दुर्गम पंचायत किन्नू के रुनपू गांव के साथ मशन किन्न के बीच पैदल चल रही चार महिलाएं और एक बच्चा भूस्खलन की चपेट में आ गए। इस हादसे में गांव रुनपू की अनीता देवी (33) की मौके पर ही मौत ऊना में खाई में गिरी स्कूल बस, चार बच्चों को गंभीर चोट

धर्मशालाः ऊना जिले से दस किलोमीटर दूर लमलैहड़ी पंचायत में एक निजी स्कूल की बस के खाई में गिरने से एक दर्जन बच्चे घायल हो गए जिनमें चार को गंभीर चोटें आई हैं। ये हादसा उस वक्त हुआ जब दोपहर तीन बजे छुट्टी के बाद बस बच्चों को घर छोड़ने जा रही थी कि अचानक अनियंत्रित होकर करीब साठ फूट गहरी खाई में जा गिरी। बस के खाई में गिरते ही परखच्चे उड गए। हादसे के पता चलते ही स्थानीय लोग तुरंत मौके पर पहुंचे और खाई से बच्चों को अस्पताल पहुंचाया। जानकारी के मुताबिक बस की हालत खराब थी और ब्रेक फेल होने के चलते बस खाई दुर्घटनाग्रस्त हो गई।

हो गई जबिक अंकिता (22), उसका बेटा कायरव (3),सतनी देवी (72) व कालदासी (47) घायल हो गए। घायलों को सराहन व खनेरी अस्पताल ले जाया गया जहां से कालदासी को आइजीएमसी शिमला रेफर कर दिया गया।

वहीं, मनाली के बाहन पुल के पास भुस्खलन होने से राहगीर बाल-बाल बचे। मौके पर मौजूद लोगों ने सीटियां बजाकर वाहन रुकवाए। भूरखलन होने से कुल्लू-मनाली राष्ट्रीय मार्ग डेढ़ घण्टा बन्द रहा। सामने रह रहे लोगों ने शाम लगभग चार बजे साफ मौसम के बीच मलबा आता देखा। उन्होंने सीटियां मारकर पैदल जा रहे लोगों को सतर्क किया। मलबा गिरता देख लोगों ने हल्ला मचाया ओर आर-पार होने वाले वाहनों को रोका।

कुल्लू में तीन दिन पहले करपट नाले में आई बाढ़ टलने का नाम ही नहीं ले रही। संभावित खतरे को देखते हुए ग्रामीणों ने घर-बार छोड़ दिया है और जंगल में ही तंब लगाकर रह रहे हैं। नदी का बहाव रूकने से यहां तीन सौ मीटर सड़क भी पानी में डूब गई है जिससे चांगुट व खंजर गांव का उदयपुर से संपर्क कट गया है। करपट व तिंगरट पंचायत के ग्रामीण फसलों को मंडियों तक नहीं पहुंचा पा रहे हैं।
