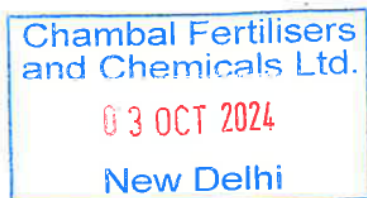

We respectfully request your assistance in obtaining a duplicate share certificate and subsequently dematerializing the shares.



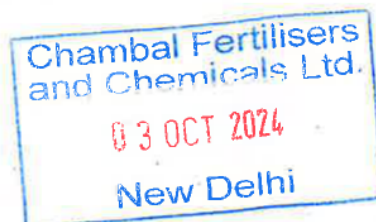
