Russia uses Zircon hypersonic missile Kiev: Ukraine has claimed it has evidence that Russia fired an advanced hypersonic missile -- one that experts say is almost impossible to shoot down -- for the first time in the almost two-year-old war, a media report said.

Jailed former Thai PM to be released Bangkok: Jailed former Thailand prime minister Thaksin Shinawatra is set to be released soon, Justice Minister Taweewee Sodsong said on Tuesday.

Plane lands safely after door falls off Cheektowaga (US): A small plane with two people aboard landed safely at Buffalo Niagara International Airport on Monday after its rear door fell off, police said.

Pakistan People's Party chairman Bilawal Bhutto Zardari on Tuesday withdrew from the race for the prime minister, saying that his party would support Pak-



istan Muslim League-Nawaz's candidate for the premier's slot without being part of the government. The decision of Bilawal came hours after Pakistan's former prime minister Shehbaz Sharif on Tuesday reaffirmed that Pakistan Muslim League-Nawaz (PML-N) supreme Nawaz Sharif will become the prime minister for a record fourth time.

Biden says 'key elements' of a Gaza deal are on table

With the threat of an Israeli ground offensive looming in Rafah, Joe Biden has said the US would do "everything possible" to make a ceasefire happen.

After a meeting with Jordan's King Abdullah II, Biden said that "the key elements of the deal are on the table," but "there are gaps that remain."

Senior officials from the US, Egypt, Israel and Qatar were expected to meet in Cairo to work on a three-phase framework that would see the release of hostages and achieve an extended pause, sources familiar with the matter told the Reuters news agency.

Abdullah said Biden's leadership was "key to ad-

ressing this conflict," as he raised the plight of the tens of thousands of civilians killed and wounded in the fighting. "We need a lasting ceasefire now," the king said. "This war must

more than one million Palestinians sheltering in the southern Gaza city, he said.

Rafah has come under heavy Israeli air strikes in recent days, with a number of casualties reported.

A Palestinian doctor told the BBC people in Rafah were living in fear.

Last week, Israel's Prime Minister Benjamin Netanyahu announced that he had ordered troops to prepare to expand its ground operation to Rafah. He vowed to defeat Hamas gunmen hiding in the city.

UN human rights chief Volker Turk said any assault would be "terrifying" and many civilians "will likely be killed."

China asks Israel to halt operations

China on Tuesday called on Israel to halt military operations in Gaza as soon as possible, a day after Israeli forces rescued two hostages from the Gaza Strip in a dramatic operation that also killed at least 74 Palestinians.

China's Foreign Ministry added in a brief statement on Tuesday that Israel should "do everything possible to avoid casualties among innocent civilians and prevent a more devastating humanitarian disaster in Rafah."

China has consistently opposed the Israeli offensive, calling from the start for a ceasefire and talks to find a permanent solution to the crisis.

The Palestinian death toll has surpassed 28,000 people, according to the Health Ministry in Gaza. A quarter of Gaza's residents are starving.
