Short News

Congress protest leads to massive traffic jam, chokes South Mumbai



Mumbai :

Heavy traffic congestion was witnessed around Girgaon band stand area in South Mumbai on Monday owing to the protest march called by the Congress to the residence of Opposition leader Devendra Fadnis and counter-mobilisation by the BJP. Traffic police authorities revealed that the protest started at around 9.30 am when Congress workers started gathering.

Earlier on Monday, Mumbai police tweeted, "Traffic on Pedder Road and Girgaon Chowpatty towards South Mumbai has been affected due to the gathering of protesters at Girgaon Band Stand. You are requested to take an alternative route." The agitators gathered and sat on the main junction at Girgaon which caused traffic on Pedder Road and the backlog went up to Haji Ali. Initially, we tried using a diversion, but due to heavy traffic movement on a Monday morning, congestion happened on alternative routes as well," an officer said.

The officials added that the agitators were removed from the road and traffic movement was gradually being restored. Joint Commissioner of Police Rajwardan (traffic) said, "Now the agitation is winding up. Traffic is gradually being restored."

Nearly two weeks after arrest in exam scam case, IAS officer yet to be suspended

Mumbai :

NEARLY TWO weeks after IAS officer Sushil Khodwekar was arrested in the paper leak scam by the Pune police, the official is yet to be suspended by the Maharashtra government. According to the All-India Civil Services rules, an officer must be suspended if he is in custody for more than 48 hours. Pune Police Commissioner Amitabh Gupta had sent a report to the state government on the same day of Khodwekar's arrest and the official is now lodged in Yerwada jail.

Chief Secretary Debashish Chakrabarty told The press, "The suspension will happen anytime now. Some more information was sought." While Additional



Chief Secretary In-Charge of General Administration Department Sujata Saunik said that the proposal was awaiting government approval. Sources in the state government said there may be a delay by some bureaucrats while suspending their fellow officer. Khodwekar is an IAS officer of the 2011 batch and is working with the Agriculture Department as a deputy

secretary. He was arrested for his role in the education department where he was a deputy secretary till November 2020. Starting with the investigation into a paper leak in the recruitment process of Group D employees of the Health Department in November last year, the cyber cell of Pune city police further unearthed a question paper leak in Maharashtra Housing and

Area Development Authority (MHADA) recruitment, malpractices in the TETs of 2020 and 2018, and a paper leak in the Group C recruitment process of the Health Department.

Till now, these five investigations have led to a total of 37 arrests, including those of senior government officials, middlemen, private entities contracted for recruitment processes, coaching class owners and candidates. Khodwekar was the 13th person to be arrested in the case. Police also alleged that the IAS officer went out of the way to support other accused found to be involved in illegal activities within the department. Police also want to investigate the officer's mobile phone.

Mumbai: Three spas raided; 12 booked for runnings sex racket, obscene acts

Mumbai :

The Kandivali police and Mira Bhayandar Vasai Virar (MBVV) police raided three spas last week and booked at least 12 people, including five women, for allegedly running a sex racket and for being involved in obscene acts. In the first case on February 11, acting on a tip-off, the Kandivali police sent a decoy customer to the Destiny spa near MG road in

Kandivali (west). After ascertaining that the owner and the manager were running a sex racket, an FIR was registered under section 370 (3) of the IPC and sections 3, 4, 5 and 7 of the Immoral Traffic (Prevention) Act. A woman was rescued and sent to a women's shelter home. The owner Ranjan Shetty and manager Manikant Naidu were arrested, confirmed Dinkar Jadhav, senior inspector of the Kandivali police station.



In the second case, also on February 11, the anti-human trafficking cell of MBVV police, raided Le Serene spa after a decoy customer ascertained that masseuses there were

involved in obscene acts. A woman, a worker, manager and owner of the spa were booked under section 294 (obscene act) and 114 (abetter) of IPC. In the last case on February 12, the Kandivali police raided Yuco spa near Milap theatre in Kandivali (west). Five women and two men were arrested for alleged obscene acts. The owner is a wanted accused in the case, confirmed assistant inspector Viraj Jagdale.

Court rejects bail pleas of two doctors accused of carrying out abortion on minor rape victim

Mumbai :

A SESSIONS court in Wardha rejected the bail applications of doctors Niraj and Rekha Kadam booked for allegedly carrying out an abortion on a 13-year-old rape victim, who was five months pregnant at Kadam Hospital. The bail pleas of the two were rejected on Friday. They were booked last month after a complaint was received from the minor's parents. The probe also led to the recovery of 54 bones and 12 skulls from the hospital premises. Police have

filed a separate FIR under sections of the Indian Penal Code (IPC) related to criminal breach of trust and relevant sections of the Maharashtra Medical Council Act, Medical Termination of Pregnancy Act and Environment Protection Act.

In the first FIR, the sessions court recently also rejected the bail applications of two nurses at the hospital, who were booked for helping with the termination of pregnancy of the 13-year-old. The nurses, Sangita Kale and Puja Dahat had filed for bail stating



that they were falsely implicated and that their signatures were taken on blank papers and at most a case of destruction of evidence can be made against them. Police had opposed bail to the accused stating that the investigation is still in progress and witness

statements are still to be recorded. For the nurses, the police said that they do not have the requisite medical certificates to practice. The court said that the nurses were on duty on the day of the incident that happened in January according to the records. It also said that Kale had given tablets to the victim for

termination of her pregnancy.

"Considering the nature of their work in the medical field, the applicants (nurses) have knowledge of medicines and consequences of administering said medicines. Therefore, it was expected to take proper care and precaution when applicants were aware of the fact that the minor victim is aged about 13 years and is five months is pregnant. The life of the victim was at risk due to the administration of medicine," the court said. The court said that the charges of non-reporting of an offence under the Protection of Children from Sexual Offences (POCSO) Act, disappearance and disposal of evidence by disposing of the foetus is a serious offence.
