

पेट्रोल और डीजल के दाम आम चुनाव का अंतिम चरण समाप्त होने के बाद ही बढ़ने शुरू हो गए थे। पिछले नौ दिनों में इनके दाम में 70 से 80 पैसे प्रति लीटर तक बढ़ चुके हैं। के दाम में 20 मई से वृद्धि हो रही है। लोकसभा चुनावों का अंतिम चरण 19 मई को पूरा हुआ। सार्वजनिक क्षेत्र की तेल कंपनियों की अधिसूचनाओं के अनुसार पेट्रोल पिछले नौ दिनों में 83 पैसे और डीजल 73 पैसे महंगा हुआ है।

अंतरराष्ट्रीय बाजार में तेल के दाम में वृद्धि के बावजद अप्रैल और मई के दौरान कीमतें एक दायरे में रही। मंगलवार को पेट्रोल के दाम 11 पैसे और डीजल में 5 पैसे की वृद्धि हुई। इस वृद्धि के बाद पेटोल अब दिल्ली में 71.86 रुपए लीटर हो गया जो 19 मई को 71.03 रुपए था। इसी प्रकार, डीजल का भाव 19 मई के 65.96 रुपए लीटर से बढ़कर 66.69 रुपए लीटर पर आ गया। इस वृद्धि के बाद मुंबई में पेट्रोल 77.47 रुपए प्रति लीटर और डीजल 69.88

रुपए लीटर पर पहुंच गया।

उद्योग जगत से जुड़े सूत्रों के अनुसार पहले चुनाव के दौरान सार्वजनिक क्षेत्र की इंडियन आयल कारपोरेशन, भारत पेट्रोलियम कारपोरेशन लिमिटेड और हिंदुस्तान पेट्रोलियम कारपोरेशन ईंधन के दाम पूरी तरह से स्थिर रखती रहीं हैं लेकिन इस बार आम चुनावों के दौरान उन्होंने दोनों ईंधन के दाम में हल्की वृद्धि ही की। अंतरराष्ट्रीय बाजार के मृताबिक पेट्रोल, डीजल के दाम जितने बढ़ने चाहिए थे उनका पूरा बोझ ग्राहकों पर नहीं डाला गया।

कंपनियां अब उसकी वसुली कर रही हैं। सार्वजनिक क्षेत्र की इन कंपनियों ने इससे पहले कर्नाटक चुनाव के दौरान मई 2018 में पेट्रोल, डीजल के दाम पुरी तरह स्थिर रखे। जबकि इस दौरान अंतरराष्ट्रीय बाजार में ईंधन का दाम करीब पांच डालर प्रति बैरल तक चढ़ गया था। लेकिन चुनाव खत्म होते ही पूरा बोझ ग्राहकों पर डालर दिया गया। दिसंबर 2017 में गुजरात विधानसभा चुनाव के दौरान भी ऐसा ही किया गया।

घरेलू शेयर बाजारों बीएसई और एनएसई के सूचकांक मंगलवार को लगातार तीसरे दिन कारोबार की समाप्ति पर नई ऊंचाई पर बंद हुए। लोकसभा चुनावों में भाजपा को मिली शानदार जीत से निवेशक की धारणा मजबूत बनी हुई है। कारोबार के दौरान भारी उतार-चढ़ाव के बीच, बंबई शेयर

बाजार का 30 शेयरों पर आधारित संवेदी सूचकांक 66.44 अंक बढ़कर 39,749.73 अंक पर बंद हुआ। कारोबार की समाप्ति पर यह सूचकांक का अब तक का सर्वकालिक उच्च स्तर है। नेशनल स्टॉक एक्सचेंज का निफ्टी चार अंक की मामूली बढ़त के साथ 11,928.75 अंक पर बंद हुआ। यह निफ्टी का कारोबार की समाप्ति पर अब तक सर्वोच्च स्तर है। लोकसभा चुनावों में भाजपा को मिली शानदार जीत से निवेशक की धारणा मजबूत बनी हुई है लेकिन अब निवेशक धीरे-धीरे वैश्विक और घरेलू कारकों जैसे व्यापार शुल्क विवाद, वृहद आर्थिक आंकड़े और मानसून की शुरुआत समेत अन्य चीजों पर ध्यान केंद्रित कर रहे हैं। निरंतर विदेशी निवेश ने भी बाजार का समर्थन किया।

सुचकांक में शामिल शेयरों में यस बैंक सबसे ज्यादा लाभ में रहा। इसमें 4.06 फीसद की तेजी रही। अन्य शेयरों में कोल इंडिया, इंफोसिस, पावरग्रिड, वेदांता, रिलायंस, टीसीएस, हिंदुस्तान युनिलीवर, ओएनजीसी, एचसीएल टेक, इंडसइंड बैंक, एचडीएफर्सी बैंक और एशियन पेंट्स में 2.72 फीसद तक की मजबूती आई। वहीं हीरो मोटोकॉर्प, बजाज ऑटो, भारती एयरटेल, एलएंडटी, बजाज फाइनेंस, महिंद्रा एंड महिंद्रा, टाटा स्टील, एचडीएफसी, कोटक बैंक और आइटीसी सबसे ज्यादा नुकसान में रहे। इनमें 2.55 फीसद तक की गिरावट दर्ज की गई।
