Pursuant to the Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with Para B of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, we would like to inform the exchange that writ petition (WRIT - C No. - 8020 of 2023) filed by the UP-Sugar Mill Association (UPSMA) before the Lucknow Bench of Allahabad High Court challenging the amendments in the Molasses Policy for the year 2022-23 and quantum of the levy obligation being computed by the State Excise department has been withdrawn by UPSMA and the said withdrawal application has been allowed by Lucknow Bench of Allahabad High Court.

Requisite details pursuant to Regulation 30 of the Listing Regulations read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 are enclosed herewith as Annexure - A.

Annexure - A

- a. the details of any change in the status and / or any development in relation to such proceedings;**

The UP-Sugar Mill Association (UPSMA) had filed a writ petition on August 11, 2023 before the Lucknow Bench of Allahabad High Court challenging the amendments in the Molasses Policy for the year 2022-23 and quantum of the levy obligation being computed by the State Excise department.

UPSMA filed an affidavit for withdrawal of petition i.e. WRIT - C No. 8020 of 2023 with the registry office of Hon'ble High Court, Lucknow Bench and the Hon'ble High Court, Lucknow Bench vide order dated 28.10.2023 allowed the application for withdrawal of the abovementioned writ petition. Copy of the said order was received on 30.10.2023.

Withdrawal of above-mentioned writ petition creates a financial liability on the Company of approximately Rs. 20.30 Crores.

This is in continuation to the disclosure made by the Company related to details of material pending litigations under Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 submitted by the Company with Stock Exchanges on August 19, 2023.
