Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that operations of our plant situated at Dadra Village of Silvassa District are partially affected due to stoppage of production, in view of illegal strike announced by the Workers w.e.f. May 31, 2024.

The matter has been brought to the notice of the office of Labour Commissioner. Further the Management is in continuous discussions with the workers and authorities to resolve the issue as soon as possible and will provide update on further developments in due course.
