("Covington"), which in turn is a wholly owned subsidiary of MHR Holdings (Mauritius) Limited ("MHR"), which in turn is a wholly owned subsidiary of MHRIL and a subsidiary of the Company, has been voluntarily liquidated with effect from 10th October, 2024.

Consequent to the above, HCR Rus LLC has ceased to be in existence and as such has ceased to be a wholly owned subsidiary of HCR, Covington, MHR, MHRIL and a Subsidiary of the Company, with effect from 10th October, 2024.

This information has been received by the Company from MHRIL on 12th October, 2024 at 09.35 a.m. (IST).

("Covington"), which in turn is a wholly owned subsidiary of MHR Holdings (Mauritius) Limited ("MHR"), which in turn is a wholly owned subsidiary of Mahindra Holidays & Resorts India Limited ("the Company"), has been voluntarily liquidated effective from October 10, 2024. This information has been received by the Company from HCR on October 11, 2024 at 9.42 p.m. (IST).

Consequent to the above, HCR Rus LLC has ceased to be in existence and as such has ceased to be a wholly owned subsidiary of HCR, Covington, MHR and that of the Company effective from October 10, 2024.
