

## REPORT OF SCRUTINIZER ON POSTAL BALLOT THROUGH E-VOTING PROCESS OF SAINT-GOBAIN SEKURIT INDIA LIMITED

I, V. N. Deodhar, proprietor of M/s V. N. Deodhar & Co., Company Secretaries having office at 4/3, Radha, 1st Floor, Shastri Hall, Grant Road (West), Mumbai 400007 was appointed as Scrutinizer for the purpose of scrutinizing the E-voting process in Postal Ballot in a fair and transparent manner for the resolution to be passed by Postal Ballot of Saint-Gobain Sekurit India Limited and ascertaining the requisite majority on E-voting in Postal Ballot carried out as per Sections 108, 110 & other applicable provisions of the Companies Act, 2013 ("the Act") read with the Companies (Management and Administration) Rules, 2014 and in accordance with Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. The Company sought approval of Members to the Resolution via Postal Ballot through E- Voting Process:

1. The E-voting period commenced at 9.00 a.m. on Monday, 28th September, 2020 and ended at 5.00 p.m. on Tuesday, 27th October, 2020. The E-voting module was disabled by CDSL for voting thereafter.
2. Voting rights were on the paid-up value of shares registered in the name of the member as on the Cut Off date i.e. 18<sup>th</sup> September, 2020.
3. The Shareholders holding shares as on the "Cut Off" date i.e. 18<sup>th</sup> September, 2020 were entitled to vote on the proposed Resolution as mentioned in the Notice of the Postal Ballot.



4. After the E-voting was concluded the votes cast through Remote E-voting were unblocked in the presence of two witnesses, namely, CA. Hrushikesh V. Deodhar and Mr. Ajit Ukidwe, who acted as witnesses and who are not in employment of the Company.
6. Thereafter I as scrutinizer duly compiled the details of Remote E-voting done by the members.

**We Submit our Report as Under:**

The result of E- Voting process for Resolution is as under:

**RESOLUTION**

**1. Sell / transfer / assign the leasehold rights:**

To consider and if thought fit, to pass, with or without modification, the following resolution as a Special Resolution through Postal Ballot:

“RESOLVED THAT pursuant to the provisions of Section 180(1)(a) of the Companies Act, 2013 (the “Act”) and any other applicable provisions, if any of the Act, or any amendment or modifications thereof and pursuant to the provisions of the Articles of Association of the Company, consent of the Company be and is hereby accorded to the Board of Directors (hereinafter referred to as the ‘Board’, which term shall be deemed to include any Committee thereof which the Board may hereinafter constitute to exercise its powers including the powers conferred by this Resolution) to sell, dispose, transfer, assign the leasehold rights of the Company’s plots at Bhosari received from Maharashtra Industrial Development Corporation (“MIDC”) on “as is where is basis” to A2ir Industries Pvt. Ltd, Rpindospace Pvt. Ltd. and / or Unnati Industrial Estate, (hereinafter referred to as “prospective Buyers”) at such negotiated aggregate consideration which shall not be less than Rs.32.50 crores, on such terms and conditions as may be deemed fit by the Board.

“RESOLVED FURTHER THAT the Board be and is hereby severally authorized to finalise and execute necessary documents including but not limited to definitive agreements, deeds of assignment / conveyance and other ancillary documents and in such manner as is decided by the Board to do all such other acts, deeds, matters and things as they may deem necessary and/or expedient to give effect to the above Resolution”.
