To consider and if thought fit, to pass with or without modification, the following Resolution as a **SPECIAL RESOLUTION**:

To divest assets of material subsidiary of the Company:

"RESOLVED that pursuant to the provisions of Regulation 24(6) and other applicable Regulations, if any, of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("the Listing Regulations") and pursuant to the applicable provisions of the Companies Act, 2013 and the Rules, circulars and notifications issued thereunder ("the Act") (including any statutory modifications, amendments or reenactments therein for the time being in force), other applicable laws, the Memorandum of Association of the Company and subject to requisite statutory/regulatory and other appropriate approvals, if any, as may be required, consent of the Members be and is hereby accorded to the Board of Directors of the Company (hereinafter referred to as "Board", which term shall be deemed to include any Committee which the Board may have constituted or hereinafter constitute) to divest assets of Magdev Limited ("Magdev"), a material subsidiary of the Company incorporated in the United Kingdom, including Magdev's entire stake in Pilamec Limited ("Pilamec"), a wholly owned subsidiary of Magdev, fixed assets, movable assets, raw materials, finished goods and intellectual property rights, to Bunting Magnetics Europe Limited ("Bunting") on the terms and conditions contained in the agreements executed between Magdev and Bunting.

RESOLVED FURTHER THAT the Board of Directors or Chief Financial Officer or Company Secretary be and are hereby severally authorised to do all such acts, deeds, matters and things as may be required to give effect to the foregoing resolution, including but not limited to deciding on the timing, manner and extent of carrying out the aforesaid divestment, or negotiating, finalizing, executing, modifying and / or amending any documents or agreements, by whatever name called and to do all acts, matters and things as may be necessary in this regard and incidental thereto, without being required to seek any further consent or approval of the Members and to delegate all or any of the powers or authorities herein conferred to any Director(s) or other Officer(s) / authorised representative(s) of the Company.



RESOLVED FURTHER THAT all actions taken by the Board in connection with any matter referred to or contemplated in any of the foregoing resolutions be and are hereby approved, ratified and confirmed in all respects."

NOTES:

- 1. The Explanatory Statement pursuant to Section 102 of the Companies Act, 2013 setting out material facts in respect of the business specified above is annexed hereto.
- 2. In view of the massive outbreak of the COVID-19 pandemic, social distancing is a norm to be followed and pursuant to the Circular No. 14/2020 dated April 08, 2020, Circular No.17/2020 dated April 13, 2020 issued by the Ministry of Corporate Affairs (MCA) followed by Circular No. 20/2020 dated May 05, 2020 and Circular No. 02/2021 dated January 13, 2021 and all other relevant circulars issued from time to time, physical attendance of the members to the EGM venue is not required and general meeting be held through video conferencing (VC) or other audio visual means (OAVM). Hence, members can attend and participate in the ensuing EGM through VC/OAVM.
- 3. Pursuant to the Circular No. 14/2020 dated April 08, 2020, issued by the MCA, the facility to appoint proxy to attend and cast vote for the members is not available for this EGM. However, the Body Corporates are entitled to appoint authorised representatives to attend the EGM through VC/OAVM and participate thereat and cast their votes through e-voting. Corporate members are required to send, (before e-voting/ attending EGM) a duly certified copy of the Board Resolution authorizing their representative to attend and vote at the EGM, pursuant to section 113 of the Companies Act, 2013 (the Act) on the e-mail id secretarial@dmltd.in.
- 4. The members can join the EGM in the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the EGM through VC/OAVM will be made available for 1000 members on first come first served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the EGM without restriction on account of first come first served basis.
- 5. The attendance of the members attending the EGM through VC/OAVM will be counted for the purpose of reckoning the quorum under Section 103 of the Act.
- 6. Pursuant to the provisions of Section 108 of the Act read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended) (Listing Regulations), and the Circulars issued by the MCA dated April 08, 2020, April 13, 2020 and May 05, 2020 the Company is providing facility of remote e-voting to its members in respect of the business to be transacted at the EGM. For this purpose, the Company has entered into an agreement with National Securities Depository Limited (NSDL) for facilitating voting through electronic means, as the authorized agency. The facility of casting



votes by a member using remote e-voting system as well as venue voting on the date of the EGM will be provided by NSDL.

- 7. All the documents referred to the Notice will be available for inspection in electronic mode. Members can inspect the same by sending email to secretarial@dmltd.in.
- 8. In line with the MCA Circular No. 17/2020 dated April 13, 2020, the Notice calling the EGM has been uploaded on the website of the Company at www.deltamagnets.com. The Notice can also be accessed from the websites of the Stock Exchanges i.e. BSE Limited and National Stock Exchange of India Limited at www.bseindia.com and www.nseindia.com respectively and the EGM Notice is also available on the website of NSDL (agency for providing the Remote e-Voting facility) i.e. www.evoting.nsdl.com.
- 9. In compliance with the aforesaid MCA Circulars and SEBI Circular dated May 12, 2020 and January 15, 2021, Notice of the EGM is being sent only through electronic mode to those members whose email addresses are registered with the Company/ Depositories. Members may note that the Notice will also be available on the Company's website www.deltamagnets.com, websites of the Stock Exchanges i.e. BSE Limited and National Stock Exchange of India Limited at www.bseindia.com and www.nseindia.com respectively, and on the website of NSDL https://www.evoting.nsdl.com

Any person holding shares in physical form and non-individual shareholders, who acquires shares of the Company and becomes member of the Company after the notice is sent through email and holding shares as of the cut-off date i.e. Thursday, September 30, 2021, may obtain the login ID and password by sending a request at evoting@nsdl.co.in or Issuer/RTA. However, if you are already registered with NSDL for remote e-voting, then you can use your existing user ID and password for casting your vote. - 13. Since the EGM will be held through VC / OAVM, the Proxy Form, Attendance Slip and Route Map are not annexed to this Notice.



14. Voting through electronic means:

In compliance with the provisions of Section 108 of the Act read with the Companies (Management and Administration) Rules, 2014 (including any statutory modification(s), clarification(s), exemption(s) or re-enactment(s) thereof for the time being in force), Regulation 44 of the Listing Regulations and SS – 2, the Company is providing to its members with the facility to cast their vote electronically ("remote e-Voting") using an electronic voting system provided by National Securities Depository Limited ("NSDL"), on all the business items set forth in the Notice of EGM and the business may be transacted through such remote e-voting. The instructions for remote e-Voting explain the process and manner for generating/receiving the password and for casting of vote(s) in a secure manner. However, the members are requested to take note of the following items:

THE INSTRUCTIONS FOR MEMBERS FOR REMOTE E-VOTING AND JOINING EGM ARE AS UNDER:-

The remote e-voting period begins on Tuesday, October 5, 2021 at (IST) 09:00 A.M. and ends on Friday, October 8, 2021 at (IST) 05:00 P.M. The remote e-voting module shall be disabled by NSDL for voting thereafter. The members, whose names appear in the Register of Members / Beneficial Owners as on the record date (cut-off date) i.e. Thursday, September 30, 2021, may cast their vote electronically. The voting right of shareholders shall be in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date, being Thursday, September 30, 2021.

How do I vote electronically using NSDL e-Voting system?

- 3. Now you are ready for e-Voting as the Voting page opens.

- 5. Upon confirmation, the message "Vote cast successfully" will be displayed.
- 6. You can also take the printout of the votes cast by you by clicking on the print option on the confirmation page.
- 7. Once you confirm your vote on the resolution, you will not be allowed to modify your vote.

General Guidelines for shareholders

- 1. Institutional shareholders (i.e. other than individuals, HUF, NRI etc.) are required to send scanned copy (PDF/JPG Format) of the relevant Board Resolution/ Authority letter etc. with attested specimen signature of the duly authorized signatory(ies) who are authorized to vote, to the Scrutinizer by e-mail to akjaincs@gmail.com with a copy marked to evoting@nsdl.co.in.
- 2. It is strongly recommended not to share your password with any other person and take utmost care to keep your password confidential. Login to the e-voting website will be disabled upon five unsuccessful attempts to key in the correct password. In such an event, you will need to go through the "Forgot User Details/Password?" or "Physical User Reset Password?" option available on www.evoting.nsdl.com to reset the password.

- 4. The details of the person who may be contacted for any grievances connected with the facility for e-Voting on the day of the EGM shall be the same person mentioned for Remote e-voting.

1. Member will be provided with a facility to attend the EGM through VC/OAVM through the NSDL e-Voting system. EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013

The following Explanatory Statement sets out all material facts relating to the Special Business mentioned in the accompanying Notice:

To divest assets of material subsidiary of the Company:

Magdev Limited, incorporated in the United Kingdom ("Magdev") is a material subsidiary of the Company as defined under SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations").

Magdev carries on the business of assembly and supply of permanent magnets, magnetic assemblies and soft ferrite cores, and the supply of sendust, MPP and iron powder cores for chokes; carbonyl iron cores for high frequency applications; strip wound cores in silicon steel and nickel alloys; and iron and cobalt base amorphous and nanocrystalline cores ("Business").

Magdev has proposed to sell the Business comprising of *inter alia* Magdev's entire stake held in Pilamec Limited ("Pilamec"), a wholly owned subsidiary of Magdev, fixed assets, movable assets, raw materials, finished goods and intellectual property rights to Bunting Magnetics Europe Limited ("Bunting"), for an aggregate consideration of GBP 1,450,000 (subject to adjustments) on the terms and conditions contained in the agreements executed with Bunting ("Proposed Transaction").

Pilamec, a wholly owned subsidiary of Magdev, whose entire shareholding is being sold to Bunting by Magdev, is engaged in the business of supply of goods and services to the chemical, metal and ceramic industries. The Proposed Transaction does not *inter alia* include sale of freehold land of Magdev at Swindon, and transfer of cash balance as on the completion date. The Proposed Transaction is intended to unlock value and monetize non-core business.

In terms of Regulation 24(6) of the Listing Regulations, selling, disposing and leasing of assets amounting to more than twenty percent of the assets of a material subsidiary on an aggregate basis during a financial year shall require prior approval of the members by way of a special resolution.

For the financial year ending March 31, 2021: (i) total revenue of Magdev was INR 336,497.64 (`000); and (ii) net worth of Magdev was INR 113,180.03 (`000). This constitutes 32% of the total consolidated revenue and 31% of the total consolidated net worth of the Company for the financial year ending March 31, 2021. The assets which are proposed to be transferred constitute approx. 51% of the assets of Magdev.

In view of the aforesaid regulatory requirements, approval of the Members is sought for the Proposed Transaction.

The board of directors of the Company has, at its meeting held on September 15, 2021, approved the Proposed Transaction, subject to receipt of shareholders' approval. The Board recommends the resolution as set out in the Notice for the approval of the members as a Special Resolution.



The Proposed Transaction is not a related party transaction under Section 188 of the Companies Act, 2013 or the Listing Regulations. None of the Directors and Key Managerial Personnel of the Company and their respective relatives is, in anyway, concerned or interested, financially or otherwise, in the aforesaid Special Resolution set out in this Notice.
