The dispatch of Notice of AGM and Annual Report has been completed on June 17, 2021.

The Shareholders will be able to attend and participate in the AGM only through VC / OAVM. The details for joining the AGM through VC / OAVM has been given in the Notice of AGM sent to Shareholders.

The Bank is providing the facility to its Members to exercise their right to vote on the businesses as set forth in the Notice of the 90th AGM by electronic means through both remote e-voting and e-voting during the AGM. All the members of the Bank are requested to kindly take note of the following:

- 1. Members may attend the 90th AGM through VC by using their remote e-voting credentials.
2. The instructions for participating in the 90th AGM through VC and the process of e-voting, including the manner in which Members holding shares in physical form or who have not registered their email address can cast their vote through e-voting, are provided as part of the Notice of the 90th AGM.
3. Members whose names appear in the register of members or in the register of beneficial owners maintained by the depositories as on the cut-off date of Friday, July 02nd, 2021, shall only be entitled to avail the remote e-voting facility or vote, as the case may be, at the AGM.
4. The remote e-voting shall commence at 9:00 a.m. IST on July 06, 2021 and end at 5:00 p.m. IST on July 08, 2021 for all shareholders. The e-voting module shall be disabled by NSDL for voting thereafter. Remote e-voting shall not be allowed beyond the said date and time and once the vote on a resolution is cast by the Member, the Member shall not be allowed to change it subsequently.
5. Persons who have become shareholder of the Bank after the dispatch of the Notice of AGM and holds shares as of the cut-off date i.e. July 02, 2021 can do remote e-voting by obtaining the login ID and password by sending a request to evoting@nsdl.co.in by mentioning their Folio no. /DP ID no. However, if such shareholder is already registered with the RTA/Depository Participant for remote e-voting, then existing user ID and password can be used for casting vote.
6. Members who have cast their vote by remote e-voting prior to the AGM may attend the AGM through VC but shall not be entitled to cast their vote again. The members who have not cast their votes by remote e-voting can exercise their voting rights at the AGM. The manner of e-voting at the AGM has been provided along with the Notice of the meeting and can also be viewed at the website of the Bank at www.federalbank.co.in under the 'Shareholder Information' section.
7. The facility for joining the meeting would be kept open at least 30 minutes before the meeting and would not be closed till the expiry of 30 minutes after the meeting.
