Enhancing the anticipation surrounding Solksjaer's debut India tour, fans will also get the chance to acquire exclusive

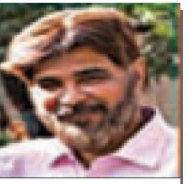
memorabilia, sourced meticulously by Tilak.
