# Australian delegation visits Chennai to explore partnerships in healthcare

Chennai, Sept 30: High-level Australian Digital Health delegates are in India as a part of the Australia - India Business Exchange 2022 Business Mission organised by the Australian Trade and Investment Commission, Australian Government.

The delegation met with the Tamil Nadu Government and local healthcare industry representatives at a roundtable on 'Digital Transformation in Healthcare - Opportunities for collaboration between Australia and Tamil Nadu' organised by the Australian Trade and Investment Commission in partnership with the Confederation of Indian Industry at Chennai on Wednesday 28 September 2022.

Palanivel Thiagarajan, Hon'ble Minister of Finance, Government of Tamil Nadu; Dr P Senthil Kumar IAS, Principal Secretary -



Health and Family Welfare, Government of Tamil Nadu; Ms Sarah Kirlaw, Consul-General, Australian Consulate-General, Chennai; Mr Abdul Ekram, Trade and Investment Commissioner, Australian Trade and Investment Commission, Australian Government and Mr Holger Kauffman, Chief Technology Officer, Australian Digital Health Agency, were part of the round table.

Palanivel Thiagarajan, Minister of Finance, said, "Tamil Nadu has been at the forefront of healthcare with 3-4 doctors for every 1,000 people, which is 3-4 times the national average and better than the US ratio. Tamil Nadu is one of the major service providers and exporters of hospital administration and medical records management systems in the World".

Recalling his recent visit to Australia, the Minister was impressed with remote medicine and remote consultations during the pandemic and the data transmission processes on vaccination statistics in Australia.

"I think we can learn a lot. There is natural fit. The people are easy to work with, there is cultural fit and lot of potential here to improve efficiency. We look forward to meaningful progress," said the Minister.

# Centralised Inhalation Conscious Sedation Unit in Saveetha

Chennai, Sept 30: A new clinical set up to deal with dental fear and anxiety in children - The Centralised Inhalation Conscious Sedation Unit installed in Saveetha Dental College Paediatric and Preventive Dentistry. Conscious sedation is a technique that depresses the central nervous system for a period of time, enabling the dentists to perform the dental procedures with a positive cooperation from the child.

During this period, the child will be in a relaxed state, with the ability to maintain a patent airway independently and also

respond to the verbal comments. Every dental chair in the Department of Paediatric and Preventive Dentistry of the college is connected with a conscious sedation unit and the institution has designed a centralised Nitrous oxide (N2O) and oxygen supply area, which supplies every individual sedation unit.

The sub-aesthetic concentration of N2O is delivered along with the oxygen from the sedation unit to the children via a nasal mask. The children getting treated under conscious sedation have shown decrease in anxiety, discomfort

and pain during the treatment. This sleep dentistry provides a Painless dental treatment for the children thereby increasing the positive attitude of the children towards dentistry.
