Sub: Intimation pursuant to Regulation 29 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Madam/Sir,

In terms of Regulation 29 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that the Board of Directors of Power Finance Corporation Ltd. (PFC) in its meeting scheduled to be held on 21.03.2023 shall inter-alia consider the following proposal:

- (i) Raising of resources i.e. Market Borrowing program for the Financial Year 2023-24 through issuance of bonds, term loans, Commercial Paper etc. from domestic & international markets. The funds will actually be raised from time to time during the Financial Year 2023-24, with the approval of competent authority as per powers delegated in this regard, by the Board of Directors in the said meeting.

In this context, in terms of Company's "Code of Practices & Procedures for Fair Disclosure of Unpublished Price Sensitive Information and Conduct for Regulating, Monitoring & Reporting of Trading in the Securities of Power Finance Corporation Limited" ('Code'), the Trading Window for trading in Equity Shares and Listed Debt Securities (Tax Free Bonds etc.) of Power Finance Corporation Limited shall remain closed with immediate effect.

Therefore, all designated persons and their immediate relatives have been advised not to deal (i.e. buy, sell or pledge etc.) in PFC's Equity Shares / Securities during the above period of Closure of Trading Window.
