## पंडित नेहरुंमुळे पाकव्याप्त काश्मीरची निर्मिती - अमित शहा

जम्मू-काश्मीरला विशेष दर्जा देणारे कलम ३७० हटविण्याचे विधेयक राज्यसभेत मंजूर करण्यात आले. यानंतर मंगळवारी कलम ३७० वर लोकसभेत वादळी चर्चा सुरु झाली. यावेळी केंद्रीय गृहमंत्री अमित शहा यांनी विरोधकांना उत्तर देताना पंतप्रधान दिवंगत पंडित जवाहरलाल नेहरू यांच्यामुळे पाकव्याप्त काश्मीरची निर्मिती झाल्याचे सांगत काँग्रेसवर टीका केली. जम्मू-काश्मीरचा मुद्दा पंडित जवाहरलाल नेहरू संयुक्त राष्ट्र संघात नेला. त्यांनी जम्मू-काश्मीरमधील कलम ३७० मर्यादित काळासाठी असल्याचे सांगितले. मात्र, ते हटवण्यासाठी ७० वर्षे लागली. कलम ३७० मुळे जम्मू-काश्मीर भारतापासून दूर होते. आता कलम ३७० हटविल्यामुळे काश्मीरबद्दल सर्व अधिकार संसदेला असणार आहेत. तसेच, कलम ३७१ रद्द करण्याचा केंद्र सरकारचा कोणताही इरादा नाही. कारण, कलम ३७० आणि कलम ३७१ यांच्यातील फरक जनतेला माहीत आहे. कलम ३७०च्या आधारे पाकिस्तानकडून फुटीरतावादी चळवळीला खतपाणी घाल्यात येत आहे, अमित शहा यांनी सांगितले. पाकधर्जिण्यांसोबत चर्चा कशासाठी करायची, असा सवाल करत अमित शहा म्हणाले, काश्मीर खोऱ्यातील जनता आपली आहे. त्यांच्याशी आम्ही कायम संवाद राहणार आहोत. काश्मीरमधील परिस्थिती बिघडू नये म्हणून कर्पूर लावण्यात आला आहे. कायदा, सुव्यवस्था कायम राखण्यासाठी इंटरनेट बंद करण्यात आले आहे. तसेच, येथील जनतेची दिशाभूल करणाऱ्यांचा प्रयत्न हाणून पाडू, असे अमित शहा म्हणाले.

कलम ३७० मुळे जम्मू-काश्मीरमधील आदिवासी, दलित, आरक्षणापासून वंचित राहिले. तसेच, या कलम ३७०मुळे बालविवाह विरोधी कायदा लागू नाही. त्यामुळे हे कलम हटविणे गरजेचे आहे. याशिवाय, लडाखला स्वतंत्र राज्य करण्याची स्थानिकांची अनेक वर्षांपासून मागणी होती. त्यामुळे लडाखला स्वतंत्र राज्याचा दर्जा दिला आहे, असे अमित शहा यांनी सांगितले.
