कलम ३७० मुळे जम्मू-काश्मीरमधील आदिवासी, दिलत आरक्षणापासून विचित राहिले. तसेच, या कलम ३७०मुळे बालविवाह विरोधी कायदा लागू नाही. त्यामुळे हे कलम हटविणे गरजेचे आहे. याशिवाय, लडाखला स्वतंत्र राज्य करण्याची स्थानिकांची अनेक वर्षांपासून मागणी होती. त्यामुळे लडाखला स्वतंत्र राज्याचा दर्जा दिला आहे, असे अमित शहा यांनी सांगितले.
