We wish to inform you that both GPBL and NS Papers have filed e- form INC 28 on August 21, 2021 with the Registrar of Companies, Kanpur along with the Certified true copy of NCLT Order.

In regard to the above, reference can be made to clause 5 ('Definitions')and Clause 7 ('Date of Taking Effect of The Scheme')of the Part B of the Scheme. Relevant extract provided below:

Clause 5.11-Order Filing Date

'Order Filing Date means the date of on which the copy of the order of NCLT is filed with the ROC for giving effect to this scheme, post approval of Resolution Plan by NCLT.'

Clause 7- Date of Taking Effect of The Scheme

'Upon the occurrence of the Order Filing Date, the Scheme shall be effective from the Appointed Date. References in this Scheme to the date of "coming into effect of the Scheme" or "effectiveness of this Scheme" shall mean Appointed Date.'
