reviewed and recommended by the Audit Committee and subsequently approved by the Board of Directors at their meeting held on October 23, 2019 in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. Their limited review report does not have any qualification/modification. The Company has adopted modified retrospective approach as per para C8 (C) (i) of IND-AS 116, Leases to its leases effective from accounting period beginning from 1 April 2019.

This has resulted in recognizing a Right of Use assets and Lease Liability as on 1 April 2019 and difference between Right of Use Assets and Lease Liability, net of deferred tax ₹ 145.07 Crores (Deferred Tax ₹ 68.43 Crores) has been adjusted in retained earnings. In the result for the current quarter ended on September 30, 2019, accounting of operating lease expenses has changed from rent of ₹ 101.13 Crores (quarter ended June 30, 2019:

₹80.77 Crores, half year ended September 30, 2019: ₹181.90 Crores) to depreciation cost for the Right of Use assets ₹74.94 Crores (quarter ended June 30, 2019: ₹59.63 Crores, half year ended September 30, 2019: ₹ 134.57 Crores) and finance cost for interest accrued on outstanding lease liability ₹ 29.34 Crores (quarter ended June 30, 2019: ₹ 28.81 Crores, half year ended September 30, 2019: ₹ 58.15 Crores). To this extent, performance for the current quarter ending on September 30, 2019 is not comparable with previous period results. The life of immovable fixed assets have been aligned with the lease term considered for IND AS 116 and accordingly the assets have been depreciated considering the lease term or

useful life whichever is lower. A charge of ₹ 2.47 Crores (quarter ended June 30, 2019: ₹ 3.75 Crores, half year ended September 30, 2019: ₹ 6.22 Crores) on account of accelerated depreciation has been taken in books on account of this alignment. The Company is primarily engaged in the business of Branded Apparels (Garments and Accessories) through retail and departmental store facilities, which in the terms of Ind AS 108 on 'Operating Segments', constitutes a single reporting segment

In accordance with the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the statutory auditors have carried out a

limited review of the consolidated financial results for the quarter ended June 30, 2019. The consolidated figures for the corresponding quarter ended September 30, 2018 as reported in the above consolidated financial results have been approved by the Company's Board of Directors, but have not been subjected to review as the Company was listed on stock exchanges only on March 8, 2019 The National Company Law Tribunal, Ahmedabad Bench vide its order dated October 26, 2018 has approved the scheme of arrangement for demerger of Branded Apparel

undertaking of Arvind Limited to Arvind Fashions Limited with effect from November 30, 2018 (the appointed date). The Scheme became effective from November 30, 2018. Pursuant to the Scheme, all the assets, liabilities, income and expenses of the Branded Apparel undertaking has been transferred to the Company from the appointed date. To the extent current quarter and half year ended on September 30, 2019 are not comparable with the quarter and half year ended on September 30, 2018. Ahead of election, govt to regularise unauthorised colonies in Delhi

Over 40 lakh in 1,797 colonies stand to benefit, property rights for a fee

IN A MOVE that will impact over 40 lakh people — a fifth of Delhi's population the Centre on Wednesday cleared the proposal to regularise 1,797 unauthorised colonies in the national capital, fulfilling a promise made by political parties in the city for almost two decades. Housing and urban

affairs minister Hardeep Singh Puri called the decision the "most farsighted, progressive, revolutionary step"taken in Delhi's history since 1947. The announcement

comes months before the Delhi Assembly polls, scheduled for February. Both Aam Aadmi Party and the BJP have, over the past year, sparred over the issue, each blaming the other for delaying the process. The Centre will intro-

duce a Bill in the Winter Session of Parliament to "recognise general power of attorney, will, agreement to sell, purchase and possession documents" — a onetime relaxation for residents of such colonies. After the implementa-

The colonies do not come under the jurisdiction of municipal bodies and, as a result, unsafe and illegal construction cannot be checked or penalised. People will have to pay a

one-time fee to register their properties, which will vary depending on the area of the property, the circle rate of adjacent authorised colonies, and the nature of land — government, private or agricultural. Puri said that 69 affluent colonies such as Sainik

Farms, Mahendru Enclave and Anant Ram Diary, or colonies in forest or protected areas, have been kept out of the purview of the cabinet's decision as it demonstrates "the government's commitment to first deal with the issues of the economically weaker sections". At a press conference

soon afterwards, Delhi Chief Minister Arvind Kejriwal, who has in the past locked horns with the Centre on the issue, welcomed the announcement and said the regularisation process must start soon.

"Till now, parties have made these promises before elections. When we came to power, we immediately took this issue up and prepared a proposal and sent it to the Centre in November 2015. We kept discussing the issue with the Centre. In July, the Centre sent a draft cabinet note and we responded promptly... This was a long struggle — for us as well as for the people of Delhi...People will only benefit once they have registry (property registration papers) in their hands, otherwise they will think it is just another empty promise," Kejriwal

ing in unauthorised colonies a key vote bank, with several policies tailor-made for them. Earlier this year, the CM made a series of announcements regarding development work — laying water pipelines and sewers and constructing roads — in such colonies. Ahead of Lok Sabha polls, the BJP too shifted its focus to unauthorised colonies. Wednesday's decision, party leaders from both AAP and BJP acknowledged, will have an impact on the outcome of next year's Assembly polls. The road ahead for DDA
