Ram Navami violence: 12 more arrested for stone-pelting

Vadodara: The Detection of Crime Branch (DCB) have arrested 12 more persons for rioting and stone-pelting in the walled city area of Hathikhana-Kumbhwar-wada in Vadodara on the occasion of Ram Navami on March 30. So far, the police have arrested 40 persons from both communities. In a release, the DCB stated the accused were identified through CCTV footage. Those arrested include a man who was spotted wielding a sword. "The arrested were sent to judicial custody. The process to include Indian Penal Code Section 295(B) in the FIR has also been initiated," the release said.

DCB Deputy Superintendent of Police Yuvrajsinh Jadeja said the probe revealed that the clash took place due to a quarrel between two two-wheeler riders. "We have concluded that the incident of stone-pelting, which was separate from the minor verbal altercation that took place at Panjirgar Mohalla earlier on March 30, had actually been triggered spontaneously during a traffic fight involving two-wheelers while the procession was underway and then snowballed into the riot. We are still identifying more accused through the CCTV footage. We did not seek remand of the 12 arrested on Monday as it is not needed," Jadeja said. ENS

Nothing left in Indian culture without Lord Ram, Lord Krishna: Gujarat Gov

IF LORD Ram and Lord Krishna are removed from India, nothing is left in the Indian culture, Gujarat Governor Acharya Devvrat said on Monday, adding these two great men sowed the seeds of the Indian culture. Addressing a gathering at Shree Krishna-Rukshmani Vivah Satkar Samaroh (Lord Krishna-Rukshmani marriage reception) organised by the Gujarat Pavitra Yatraddham Vikas Board (GPVVB) in temple town Dwarka, the governor said, "Hum yadi Bharat se Bhagwan Ram aur Yogeshwar Krashan ko bahar kar de to Bharat ki sanskriti mein kuchh bachata nahi. Bharat ki jo

sanskriti hain, Bharat ki jo sabhyata hain wo in dono mahapurusho se prarambh hua hain (If we obliterate Lord Rama and the god of Yoga, Lord Krishna from India, nothing is left in the culture of India. India's culture, India's civilisation started with these two great men)," Devvrat said. "If anyone who made us aware about what our married life should be like, what our society should be like, what should be duties of our king, it is Lord Rama. If someone's life inspires us to what an ideal son, father husband and a restrained person, it is Lord Rama. And we see the height of those virtues in Yogeshwar Shree Karshan," added Devvrat. "This land of Gujarat gave birth to a great social reformer Swami Dayananda Saraswati.

This Swami Dayananda Saraswati has written that in Mahabharata, Krishna's life is like aaptpurush, meaning, Lord Krishna was the only man of his time who didn't commit any sin...," said Devvrat. "In his life, he had married only once, which was with princess Rukmini... We associate such a great man, great Yogi, sthitpragya (one who observes things objectively) with thousands of marriages. These wrong traditions must have started from somewhere else," he added. Assam CM Himanta Biswa Sarma, Arunachal Pradesh CM Pema Khandu, Union Minister of State for Culture, Meenakshi Lekhi, Manipur Minister for Power Thongam Biswajit Singh and Gujarat Tourism Minister Mulu Bera also addressed the gathering.

POLICE RECORD STATEMENT Lie detector test likely for student named in Darshan Solanki's note

THE MUMBAI Police's special investigation team (SIT), which is investigating the suicide of IIT student Darshan Solanki in February, is likely to move for a lie-detector test to be conducted on the IIT student whose name was mentioned in a note purportedly written by Solanki and found in his hostel room.

In the note, Solanki purportedly said "(student name) you killed me". After registering an FIR in the case on Thursday, the SIT on Monday recorded a detailed statement of the student. According to police, the student who resided on the same floor as Solanki said three days before the latter died by suicide, Solanki had apologised to him over a dispute between them that took place earlier. Police, however, feel that the student isn't giving them all the details like the reason for the dispute, due to which they are considering methods like a lie-detector test.

A source said, "Now that an FIR has been registered in the case, we will be recording statements under Criminal Procedure Code Section 161. We have recorded the statements of two students on Monday."

In his statement, the IIT student said that on March 10, when he was out, he received multiple calls from Solanki, which he missed as his phone was in silent mode. Later, when he reached the IIT campus, Solanki hugged him and apologised about a past dispute.

"However, the student is not telling us about what led to the dispute. After recording all the statements, we are planning to go for scientific methods like a lie-detector test on the student so that we get complete details about the issue between the two of them," said a police source, adding that the student also told the police team that once he was

talking to Solanki and had mentioned that he had a cutter, and Solanki appeared to be scared. The source claimed that the statements of others recorded earlier have also mentioned a dispute between the duo in the week prior to the suicide.

Last week, the SIT had recorded the statement of Udaysingh Meena, whom Solanki was believed to have confided in about the alleged caste discrimination he was facing at the institute. The source said that Meena's statement, recorded in Rajasthan last week, stated that Solanki had told him about an IIT student who had reduced his interaction after he came to know about Solanki's score.

Meena told the police that he had advised Solanki to ignore that student and talk to others. At the end of his statement, he told the police it was possible that Solanki died by suicide due to loneliness.

"We are investigating the case by keeping all possibilities open. We are also awaiting the handwriting analysis of the note found in Solanki's room to find out if the writing is his," said a police officer.

While police had asked the family to file a complaint against the IIT student whose name was found in the note, the family did not agree and gave a complaint stating caste discrimination at the institute drove their son to suicide, based on which the FIR was registered.
