In terms of Regulation 29 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that a meeting of the Board of Directors of REC Limited will be held on **Wednesday**, **May 17**, 2023 *inter-alia* to consider and approve the audited financial results (standalone & consolidated) of the Company for the quarter and year ended March 31, 2023.
