This is with reference to the 1st Interim Dividend of Rs.22/- per equity share of Rs.5/- each fully paid up (440%) for the Financial Year 2023-24, declared by the Company on 12th February, 2024.

Any declaration towards the same shall be submitted to the Company at investors@hal-india.co.in on or before 20th February, 2024.
