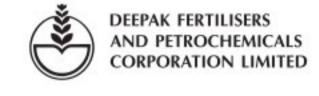

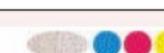

# मोदी टु पॉईंट झिरो

त्तप्रधान नरेंद्र मोदी यांच्या नेतृत्वाखालील भाजप प्रणीत 🕇 एनडीए सरकार दुसर्यांदा विराजमान झाले आहे आणि यावेळी मंत्रिमंडळात अनेक जुने मंत्री नाहीत. सुषमा स्वराज, अरुण जेटली हे दोन नेहमीचे चेहरे यावेळी मंत्रिमंडळात नाहीत. स्वराज यांनी आजारपणामुळे लोकसभा निवडणूक लढवली नाही तर जेटली यांनी आजारपणामुळे आपल्याला मंत्रिमंडळात स्थान देऊ नये, असे पत्र कालच मोदी यांना लिहिले होते. बाकी बरेचसे चेहरे तेच आहेत. नवा भव्य जनादेश घेऊन आल्याने मोदी यांना मंत्रिमंडळ बनवताना पूर्ण स्वातंत्र्य होते. मात्र मोदी यांनी जवळपास तेच चेहरे ठेवले आहेत. जुन्या बाटलीत नवी दारू असा हा प्रकार आहे. राजनाथ सिंग यांनी आपले स्थान टिकवले आहे तर काँग्रेस अध्यक्ष राहल गांधी यांचा अमेठीमध्ये पराभव करणाऱ्या स्मृती इराणी यांना अपेक्षेप्रमाणे मंत्रिमंडळात स्थान मिळाले आहे. त्यांना महत्वाचे मंत्रिपद मिळणार, हे ही स्पष्ट आहे. सर्वात चर्चित चेहरा अर्थातच भाजपचे अध्यक्ष अमित शहा यांचा आहे. अमित शहा यांनी मंत्रीपदाची शपथ घेतल्याने त्यांना कोणते महत्वाचे खाते मिळणार, याची चर्चा आहे. गृह, अर्थ, परराष्ट्र आणि संरक्षण ही चार खाती असून यापैकीच एक शहा यांना दिले जाणार, हे स्पष्ट आहे.
