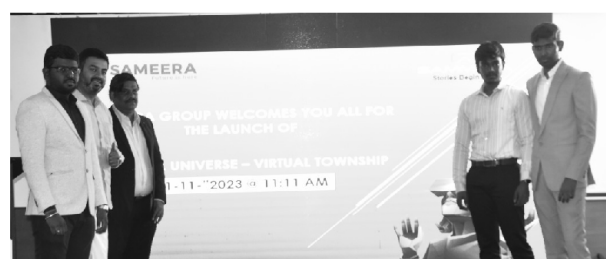

ISF announces winners of Infosys Prize in six categories

Chennai, Nov 16: Infosys Science Foundation (ISF) announced the winners of the Infosys Prize 2023 in six categories - Engineering and Computer Science, Humanities, Life Sciences, Mathematical Sciences, Physical Sciences, and Social Sciences.

Since its inception in 2008, the Infosys Prize has honored the accomplishments of the recipients and awarded them for their contributions to scientific research and scholarship impacting India.

The prize for each category comprises a gold medal, a citation, and a prize purse of USD 100,000 (or its equivalent in INR). The event was hosted at Infosys Science Foundation's office in Bengaluru.

The laureates of Infosys Prize 2023 were shortlisted from 224 nominations by an international panel of jurors comprising world-renowned scholars and experts.

1.1 lakh students attend NEET coaching in Govt schools

Chennai, Nov 16: School education minister Anbil Mahesh Poyyamozhi on Tuesday said that 1.1 lakh Class 11 and 12 students are attending coaching classes for competitive examinations being held in government schools daily across the state.

This includes 46,216 students for the National Entrance cum Eligibility Test (NEET) for medical courses and 29,279 students for Joint Entrance Examinations (JEE) for engineering courses and 31,730 students for both. He added that the department would soon announce the dates for the public examinations for classes 10, 11, and 12.

"We have already said that the dates would be announced after Deepavali. We don't want these dates to clash with various competitive examinations and they will be announced soon," said the minister.
