This has reference to the CRISIL's Rating Rationale document dated April 28, 2021 with regard to the review of CRISIL Ratings on the bank facilities of Jindal Drilling and Industries Limited ("the Company"). The said document, inter-alia, mentioned that the Company has re-contracted Jindal Explorer rig, the Letter of Award for which was received by the Company only on May 04, 2021, and that the Company is in the process of purchasing Jindal Supreme rig, for which the deal is yet to be finalized as per the Company's clarifications to SEBI. It is also mentioned that the Jindal Explorer rig had been re-contracted at a significantly higher charter rate than earlier.
- 2. The Company *vide* its email dated April 27, 2021 to CRISIL Ratings confirmed the facts contained in the aforesaid document.
- As you are aware, under Regulation 4(1)(f) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("LODR"), a listed entity is required to ensure that the channels for disseminating information provide for equal access to relevant information by investors.
- 4. Accordingly, the Company should have ensured the information provided in the aforesaid document, the facts of which were confirmed by the Company, and which is publicly available on the website of CRISIL, is at par with the disseminations / announcements through the stock exchange(s) to ensure equal access to the information through the two channels.
- 5. The aforementioned lapse in compliance with the applicable regulatory provisions is viewed seriously. You are hereby warned for failure in ensuring compliance with the applicable regulatory provisions and advised to exercise proper due diligence in future and avoid recurrence of such instances.
- You are also advised to place this letter before the Company's Board of Directors and to disseminate this letter through the stock exchanges.
