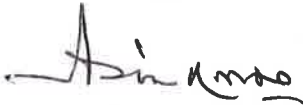
Due to some personal reasons and preoccupation, I will not continue as Whole Time Director of the Company and accordingly resign from the office of directorship with immediate effect.
